On Wednesday, Aug. 5, 1981 at 10:40 p.m., the writer received a call from the dispatcher advising to meet the uniform officers at 3275 Thomas, stated that Lt. Ronnie Oliver and another officer had been shot by a male white after robbing Wendy's Restaurant, and the male white suspect had not been apprehended.

The writer proceeded to the scene and on arriving was met by Lt. C. Keenan, Sgt. G. Ball, Sgt. D.R. Hollie of the Shoot Team and numerous uniformed officers. Lt. C. Keenan and Sgt. G. Ball were in the process of roping off the scene just north of Wendy's on the parking area, as this is where the officers had been shot. Lt. Oliver and Ptm. A.K. Stoddard had already been transported to John Gaston Hospital.

Uniform officers had secured the scene at Wendy's Restaurant and the employees were being held inside to be interviewed.

Lt. C. Keenan advised the writer that a male white, approx. 25 yrs. old, 5'6, 160 lbs., wearing blue jeans, blue hat, and blue jacket entered Wendy's Restaurant and after eating pulled a pistol and made five (5) employees go to the rear office and lay on the floor and took an undetermined amount of money and as the suspect came out the front door, the police had arrived with Lt. R. Oliver parking his car at the front door. Lt. R. Oliver approached the suspect, along with Ptm. A.K. Stoddard. The suspect ran north thru the parking area and was caught by the officer and during a struggle Ptm. A.K. Stoddard was shot in the arm and Lt. R. Oliver was shot in the chest. The suspect had left the scene running.

Lt. C. Keenan advised that Sgt. Hollie and Sgt. G. Ball had the scene investigation outside of Wendy's Restaurant and for the writer to handle the scene inside Wendy's and interview the witnesses.

The writer interviewed Kerry Kil, MW, 19, 2116 Colefax, 345-0793, employed for C.E. Meyers Carpet Cleaning Company. He stated that he had arrived at the restaurant to clean the floors and was waiting for some customers to leave. Stated this was about 9:45 p.m. as they had locked the front doors. He observed a MW sitting at the last table being approx. 20-25 yrs., 5'7, 160 pounds, wearing blue jeans, sweat shirt or jacket, blue hat and tennis shoes. After all the other customers left, the male white got up and pulled a large pistol, dark in color, and told him and Janis Foyden, FB, to get to the back and while going thru the kitchen he saw another

employee, Teresa Cleveland, FB, who was unloading the frosty machine and made her get in the back and made them lie on the floor beside the office, open the office door where the assistant manager, Toni Law, FW, was counting the money with Steve Burk and a Melinda Gant, and made them lie on the floor and took the money that was in a bag. Stated that while they were walking thru the kitchen, the suspect turned the phone off the wall and made Toni Law pull the phone off the wall in the office. Told them to wait ten (10) minutes before leaving. After he had left the office he believed that Steve Burk pushed the alarm button in the office. Stated when he came outside he saw the police car but did not see the policeman, did not hear any shots, but later saw the policeman lying on the pavement and that he had been shot. Stated he could identify the male white suspect.

Interviewed Melinda Gant, FW, 18, 1872 Portland, 358-2112, employed at Wendy's, but was not working, was just visiting the assistant manager as she was in the office when the suspect came to the door and told the others to lie on the floor. The suspect asked for the money and Toni Law gave him the money.

She states that she did not see the MW because she got scared and put her head on the desk, and did not look at him. The male white told Toni to tear the phone from the wall and he told them he had a partner outside and to do what he said or his partner would not be so nice. Told them not to come out for ten (10) minutes. Stated after he left Steve Burk pushed the alarm button. When she did come outside, she did not hear any shots, but saw the police cars outside. Stated she could not describe the male white and could not identify this male white. She stated that he wanted to know who owned the blue Cutless parked on the south side of the building and Toni Law said it was hers and he took her car keys and let her keep the other keys.

Interviewed Teresa Cleveland, FB, 23, 3163 Madewell #C, 353-5637, employed with Wendy's Restaurant. Stated she was in the kitchen when she saw the MW with a pistol, made her along with the others go to the rear office and made some of them lie on the floor outside the office, told Toni to give him all the money for her to be cool, said he had a partner outside and told them to stay in the office for ten (10) minutes, not to come out. Stated she could identify this MW.

Interviewed Janice Fondaen, FB, 19, 692 N. Third, 527-3026, employed with Wendy's Restaurant. Stated she was putting salt and pepper in the shakers and the MW was sitting at the last table east of the front door. He had eaten a hamburger, french fries, and coke and all the other customers had left when he began choking and she asked him if he wanted some water and he said no, then he got up, pulled a pistol from his belt and ordered her and the other people to the back; then made them lie down on the floor. She described the MW as 25 yrs., 5'8, 160 lbs., mustache, long brown hair, wearing blue jeans, plaid shirt, tennis shoes.

During the interviews with the above people, one of them stated that she believed a Debbie Hall her mother and brother were still in the restaurant which this MW was eating, but they had left before he pulled the gun. Stated that Toni Law, the assistant manager, would know Debbie Hall and would know where she lives, etc.

Pt. L.A. Godwin interviewed a Leonard Hood, MW, 42, 963 Frayser Cl., 353-2520, and his statement is attached to this supplement.

The scene of the armed robbery can be described as Wendy's Restaurant located at 3275 N. Thomas on the west side of Thomas Street, being a brick building, having glass windows in front and on sides. You enter the restaurant by the north side entrance thru two glass doors and there is a railing that runs east and west for the customers approaching the order counter and this counter runs north and south. The salad bar is located approx. 6 feet from the counter and there are

approximately 26 tables in the dining area. There are three tables located on the north side wall and the suspect was sitting at the last table being at the front of the restaurant. The restrooms are located off the hallway which runs east and west and from the hallway you could enter the office, however this door is locked and to enter the office area you have to go behind the serving counter, then west to the kitchen area, then north down a small hallway to the office. There is a floor safe located by the south wall in this office, which was open and contained a small amount of change in wrappers. There is a desk on the north wall which contained a small amount of change in a changer. On the west wall beside the desk is a phone and the wires had been pulled from this phone. There is an alarm button located in this office beside the desk. The alarm was installed by Freress Ulhorn Burglary Alarm Co., located at Poplar & White Station.

Located on the north wall by the refrigerator in the kitchen area is another wall phone, and this phone had been pulled from the wall and was lying in a garbage can by the north wall.

The table where the suspect was sitting is the last table from the side door on the north wall. On this table was a tray, hamburger paper, french fries wrappers, and a paper cup. These items were confiscated by Crime Scene Officer, Lt. R. Franklin, to be processed. The telephone found in the garbage can was confiscated to be processed and will be tagged by Lt. R. Franklin.

Crime Scene Officer Lt. R. Franklin, Sgt. C. Russell, and Sgt. T. Harrison took photographs of the scene inside the restaurant, and were instructed to process the table, both glass doors and the locks. The office door facing, office door and door knob, along with the outer door leading to the hallway which is kept locked, were also to be processed.

The scene was video taped by Lt. J. Johnson and Sgt. F. Hester, of Criminal Intelligence, and these tapes will be available and part of this file.

The writer proceeded to John Gaston Hospital City Morgue at 4 a.m. and on arriving was met by Sgt. G. Ball. The writers observed that Lt. R. Oliver had received one gunshot wound which appeared to be an entrance wound to his left side, approx. 8 inches below and to the side of his left nipple. This wound was large and then was sutures across his left side by the wound, which was by the doctors at John Gaston Hospital. There was what appeared to be an exit wound to his shoulder, at the arm pit, and this wound had tearing to the skin. The writer did not observe any powder burns on the wounds. There were several large abrasions to the left side of his forehead, abrasions on the outer left thumb, abrasions on his right little finger and knuckle and abrasions on his ring finger. There were large abrasions on his right elbow. The victim was only wearing shorts, as his clothes had been taken off of him at the emergency room. Crime Scene Officer Lt. R. Franklin and Sgt. Russell took photographs of the victim showing the wounds. The writer took Polaroid films of the wounds also which have been turned over to Homicide. A wound diagram chart was made by the writer. The writer bagged the victim's hands.

The scene area was well lit and the weather was hot and humid with clear skies.

He said that he would be glad to help in any way and that he would stand by in the Emergency Room Waiting Room.

I then returned to the Emergency Room Trauma Unit and talked to Ptlm. Stoddard, just momentarily prior to his being taken to Emergency. Ptlm. Stoddard briefly said that Lt. Oliver had a bearhug on the suspect and that when they fell to the ground, he also put a bearhug on the suspect and that he never saw a pistol. He said he heard the shot and felt a severe pain in his right arm and the next thing he knew he was laying on the ground, hearing several shots. Ptlm. Stoddard was then taken on to surgery and I did not talk to him further.

At approximately 0200 hours this date, I was approached by Ptlm. T. L. Cobb, IBM 1350, and Ptlm. O. M. Larkin, IBM 4799, who said they had the clothes and personal property belonging to Lt. Oliver and Ptlm. Stoddard. I went to the Detention Office at John Gaston and found that them items had been placed in a paper sack. I advised Ptlm. Cobb and Larkin to take these items to Headquarters and tag them as evidence for the Violent Crimes Bureau.

The writer took custody of Lt. Oliver's pistol, a Smith & Wesson, Model 15-2, Serial # X680279, and found it to be loaded with six spent hulls. I also took custody of Ptlm. Stoddard's weapon, which was loaded with six live rounds and it was a Smith and Wesson Model 10, Serial # 0538737. These weapons will be retained in the Legal Office until such time as they are released to the proper persons.

The clothing and other items were brought to Headquarters by Ptlm. Cobb and Larkin and property receipts were forwarded to Violent Crimes.

At approximately 0215, I was directed by Director Chapman to inform the news personnel present of the identity of the person in custody and the charges lodged against him. I did inform the news personnel present of that information.

At approximately 0220, Dr. Moore reported that the defendant's x-rays were negative and that as soon as he had sutured the lacerations that Larry Wilson could be released to our custody.

Chief Insp. Marshall had jail clothing brought from the jail to John Gaston and after Dr. Moore finished his suturing, Larry Wilson was instructed to put these jail clothing on which he did and a polaroid photograph was taken of Wilson at this time by Sgt. East. Sgt. East, also at this time, handed the suspect a line-up waiver card which he, Wilson, read and refused to sign. The suspect was then handcuffed and transported to Headquarters, arriving at the jail at approximately 0250 hours. He refused to make a phone call at 0253 hrs.

The writer then returned to service and was instructed by Lt. Keenan to report to the morgue to meet Sgt. R. K. Wilson at that location. The writer did go to the morgue, arriving there at approximately 0335 hrs and was met by Lt. R. G. Franklin and Sgt. C. A. Russell of the Crime Scene, who took photographs of the body of Lt. Oliver. Sgt. Wilson made out a wound diagram on a body chart indicating an apparent entry wound in the left side area and what appears to be an exit wound in the upper rear right shoulder area. There was evidence of contusions and bruises in the upper left forehead area. There were minor abrasions on the fingers of the right hand and the index finger of the left hand. Sgt. Wilson is submitting areport on the details of his investigation at the morgue.

The writer returned to Headquarters and found that a show-up involving the suspect was in progress. After the show-up, the writer joined Insp. Hess, Capt. Jackson, Capt. Lewis, Lt. Music, Lt. Keenan, Sgt. Hollie and Sgt. Wilson in the Violent Crimes Office where an exchange of information took place.

At approximately 10:40 PM on August 5, 1981, the writer received a call from the Dispatcher and advised that a shooting had occurred at 3275 N. Thomas and that possibly a police officer had been shot. I went immediately to 3275 N. Thomas and as I arrived on the scene at approximately 11:00 PM, I saw a large crowd gathered in the front area and the north parking lot area of Wendy's Restaurant at that location. There were numerous television and other media personnel on the scene at this time. There was an area on the north parking lot of Wendy's which had been roped off and crime scene placards attached. There were numerous uniform and plain clothes police officers on the scene when I arrived and after several minutes, I did locate Lt. C. W. Keenan, who advised that a hold-up alarm had come in to the Police Department and that Car 105, Lt. R. D. Oliver, had made the call, along with another car, and that two officers had been shot and had been taken from the scene by Fire Department Ambulance.

I was instructed by Lt. Keenan to rope off an additional section of the north parking lot to insure that evidence on that lot was not destroyed by persons walking in the area. There was a large accumulation of blood on the parking lot and what appeared to be a blue jacket with a white sack near the blood spots. I was instructed to interview three witnesses who had arrived on the scene and I began to interview these three witnesses.

I first talked to John Kenny, M/W, 50, 835 Par, home phone 357-7262. Mr. Kenny said he had driven up to the north side of Wendy's Restaurant at approximately 10:20 PM, and had parked his car in one of the aloted parking spaces on the north side of the building and that he and his wife and another lady had exited his vehicle and had approached the door on the north side of Wendy's, which door actually faces east, and had attempted to open the door and found that it was locked. Mr. Kenny said that he knew that the normal closing hours for Wendy's was approximately 11:00 PM and that it made him mad that the door was locked, indicating to him that the business was closed. He said that he pulled on the door several times, trying to attract the attention of a M/W who was inside the store in the area which Mr. Kenny called the vestibule. This area is the area between the two doors on the north side of the building which actually face east and west. Mr. Kenny said that a M/W was kneeling down near what appeared to be cleaning equipment and that the M/W would not look up when he attempted the door. He said that this M/W was 28 years old, 160 lbs, medium to slender build, with beige overalls and a blue cap with hair sticking out from under the cap. He said the hair appeared to be sandy blonde colored hair. Mr. Kenny said that he stayed at that door for approximately

2 to 3 minutes before returning to his vehicle. Mr. Kenny indicated that he believed that this party whom he had described, was responsible for the hold-up. It was later determined by the writer that the person Mr. Kenny described was actually the clean up man, who was inside the building at the time of the hold-up. Mr. Kenny saw the clean up man sitting at a table inside Wendy's waiting to be interviewed by Sgt. R. K. Wilson and did say that the person appeared to be the same one that he had seen at the time he tried the door.

I then talked to Eva Sue Kenny, who accompanied her husband to the door and stood to the east of Mr. Kenny while he tried the door. Mrs. Kenny said she paid no attention to the person kneeling in the vestibule but that she did see a M/W eating at a table in the extreme north east corner of the Wendy's building. She described this M/W as being in his late 30's to early 40's with a light colored baseball type cap and a light shirt. Mrs. Kenny said she paid no particular attention to this person and did not believe that she would be able to recognize him again, should she see him.

I then talked to Nikki Wood, F/W, 812 Brad #1, home phone 353-4129, who said she accompanied Mr. and Mrs. Kenny to Wendy's and that she saw the person in the vestibule describing him as a M/W with a puggy face dressed in a blue cap and blue jacket. Ms. Wood was apparently describing the same clean-up person which Mr. Kenny had earlier described.

I then talked to Jeff Rickard, M/W, 19, 1842 St. Elmo, home phone 358-1429, who advised that he was at the Corner Grocery at Thomas and Frayser Blvd. and that there were two squad cars parked in front of this grocery when he heard what sounded like 9 to 12 shots. In quick repetition with one break in the sounds after the first 5 or 6 shots. He said the two police cars, which were on the lot at the Grocery, immediately pulled toward the sound of the shooting and that he jumped in his car and followed them. He said that as soon as he turned the corner, he saw a M/W with dark clothes with a cap on, approximately 5'10" and 140 to 155 lbs, carrying a chrome colored pistol run north in front of the Holiday Auto Parts, which is the first business north of Wendy's. He said this M/W appeared to be holding his head with his right hand while running. He said that he did not believe that he would be able to identify this person if he saw him again. He said he did not witness the actual shooting but that he did see the officers lying on the parking lot area.

It may be noted while talking to Jeff Rickard, the writer heard the dispatcher put out information that the suspect was in the weeded area behind Holiday Auto Parts and notified several cars to pull into that area. I stopped my conversation with Rickard and began to go toward the area where I could see flashlights and hear a commotion. I heard one of the cars say that the suspect was under arrest and I returned to finish the interview with Jeff Rickard. Shortly after finishing this interview, I was instructed by Lt. Keenan to report to John Gaston to attempt to obtain information from the arrested party who had been taken to John Gaston Hospital.

I proceeded to John Gaston Emergency Room, arriving there at approximately 0030 hours. There were numerous media and police personnel on the scene and after entering the Emergency Room, I talked to Lt. J. O. Hamby who advised that the suspect had possibly been shot and was in the trauma section of the Emergency Room. He accompanied me to this section, where I first saw the M/W suspect, later learned to be Larry Wilson. Wilson was lying on his stomach with the rear portion of his pants ripped and I could see several scratches and dog bites on the lower portion of the body. The doctor's aids were cutting the blue jeans off of his person. A gown was being put over the upper portion of his body. When he was turned over, I noticed a considerable amount of blood on the facial area and on the upper torso area. I asked the doctor who was treating him, who I learned to be Dr. Fred Moore, if I could talk to the suspect and attempt to determine whether or not he was the party responsible for the hold up and shooting and whether he was accompanied by ~~the~~ any others.

On Wednesday, Aug. 6, 1981, approx. 10:35 p.m., the writer responded to 3275 N. Thomas in regards to an Armed Robbery in which two officers had been shot. Upon arriving on the scene the writer saw an Fire Department Ambulance being driven by Sgt. T.M. Jones #4171. It was learned that Sgt. Jones was driving the ambulance while the paramedics worked on Lt. R.D. Oliver.

The writer met with Lt. C.W. Keenan and was advised that other members of the Shoot Team were enroute. He advised that an Armed Robbery had taken place at Wendy's Restaurant and when Lt. Oliver attempted to apprehend the suspect, he was shot and wounds appeared very serious. Lt. Keenan also advised that Ptlm. A.K. Stoddard also had been shot by the hold up suspect, but the wound did not appear serious. The male white suspect had escaped from the scene and was still at large.

At this point Lt. Keenan and the writer began roping off the crime scene area which consisted of the north side of the parking lot of Wendy's and the parking lot of Holiday Auto Parts at 3209 N. Thomas. While roping off the crime scene we were joined by Sgt. Ball, Wilson, and Collier of the Shoot Team. It was determined that Sgt. Wilson would handle the victim and witnesses inside Wendy's Restaurant; Sgt. Ball would handle the witnesses outside of Wendy's Restaurant; Sgt. Collier would go to the home of Lt. Oliver and get his wife and take her to the hospital and the writer would handle the crime scene on the outside.

The writer was met on the scene by Ptlm. T.N. Harrison #3331, Car 2330, and it was discussed as to what photographs and measurements were needed. It had been learned that the suspect dropped his baseball type cap in front of Lt. Oliver's squad car, which was parked just outside the entrance of Wendy's. Moving in a northerly direction the next item was a flash light, which was approx. 35' from the front of Lt. Oliver's squad car. Found close to the building of Holiday Auto Parts were two (2) spent .45 cartridge cases and one (1) live .45 cartridge case. Lt. Oliver's police radio was also lying in this area and appeared to have been dropped as it had broken open and the battery had fallen out. A short distance from these items were large blood stains which is where Lt. Oliver fell when he was shot. Still going north, there was a blue pick up truck parked in front of the Holiday Auto Parts and an empty .45 casing was found in the rear of the truck. The truck also had a bullet hole near the driver's door, which appeared to have been made by a .38 caliber bullet.

The writer then checked the area where Ptlm. Stoddard was standing when he was shot and found a small amount of blood and nothing else.

The writer talked to Ptlm. S. C. Parker and he related the following events. He said that a hold up call to Wendy's Restaurant was put out at approx. 10:30 p.m. He stated he responded along with several other cars but before he arrived, Lt. Oliver advised the dispatcher to disregard all cars but one as it appeared there was nothing to the hold up. Ptlm. Parker was already in the area, so he pulled into the lot on the south side of Wendy's. He observed Ptlm. Stoddard going around the building to the north side. Ptlm. Parker stated he heard a shot but thought it was a car back firing. As he began to round the building he heard other shots and he observed the male white suspect facing toward Stoddard and the male white suspect fired one (1) shot hitting Stoddard in the right arm. Parker noticed Lt. Oliver on the ground and he started towards the suspect when the suspect fired one (1) shot at him. Parker dected and as he prepared to return fire the suspect went around the corner on the north side of Holiday Auto Parts and Parker lost sight. Parker then helped administer first aide to the officers, as other officers began coming to the scene. Parker advised that he would give a complete detailed written statement when needed.

The writer talked with Lt. J.R. Hays, who advised that numerous officers and commanders were on the scene and he had no way of getting a complete list. Lt. Hays advised that it was his understanding that Ptlm. Parker and O.W. Stewart were the first officers on the scene after Oliver and Stoddard. He advised that Stewart would be available to give a detailed written statement.

While on the scene it was learned that Lt. R.D. Oliver had been pronounced D.O.A. at John Gaston Hospital. Ptlm. Stoddard was listed in satisfactory condition. At this point Lt. Keman had Sgt. Ball go to John Gaston Hospital to complete the investigation there.

During this time, it was determined that the Violent Crimes Bureau would handle the case with assistance from the Security Squad. The writer had already went thru the crime scene involving the shootings of Oliver and Stoddard and all photographs and sketches would be forwarded to the Violent Crimes Office.

While on the scene it was learned that a suspect had been apprehended in the rear of 943 Frayser Ct., and the pistol used by the suspect had been recovered in the rear of 963 Frayser Circle. The suspect was transported to John Gaston Hospital for minor injuries and was to be held for the Violent Crimes Bureau.

All items of evidence were confiscated by crime scene officers and properly marked and tagged in the property room for the Violent Crimes Bureau. A white canvas money bag, taken by the MW suspect, was found on the parking lot between Wendy's and Holiday Auto Parts. This bag was taken by the writer and turned over to Russell Spencer, MW, 984 Catbird Ct., 685-5459, bus. 382-1006, who is the area director for Wendy's Restaurants. Mr. Spencer took this bag to the kitchen area and counted the money in the bag which totaled \$1,170.25. Lt. R.G. Franklin, of the Crime Scene, took photos of Mr. Spencer with the money, then the money was turned over to Mr. Spencer.

The writer talked to Vicki Mason, FW, 23, 1967 Burnham, 353-1511, employed at Baker's Big Star, 357-7617, who stated that she had been north on Thomas in front of Wendy's when she looked to her left and saw two men struggling in the parking lot. She heard what sounded like a shot and one of the male whites threw up his hands, staggered backwards a couple of feet, and fall. She described the male white standing as having brownish blond, long straight, hair, young looking, wearing jeans and a blue shirt. She stated she saw this MW with a gun and heard a total of possibly three shot.

She did not know that the person she saw fall was a police officer. When she got home she told her husband what she had seen and he told her that a police officer had been shot in that area and she should notify the police. Ms. Mason advised she did have to go to work shortly but she got off work at 3 p.m. and would gladly cooperate in giving a detailed statement.

Dr. Moore advised that it would be allright to talk to the suspect because he did not appear to be too seriously injured on his preliminary examination. I then identified myself to the M/W and asked him his name. He said that his name was Larry Wilson and he was from Ft. Worth, TX. I asked him what had happened to him and he made the statement that he had "given up and had his hands in the air", and had struggled with officers. He was mumbling incoherently part of the time and making rambling statements without having been asked the questions. He did say that he tried to give the officer the gun but that the officer started fighting with him and the gun went off accidentally. He said the gun fired only one time. I asked him if he was referring to the incident as he left Wendy's and he said "Am I not supposed to be given my rights". I ceased questioning him at this time. It may be added that during one of his rambling statements he did say that he was alone and had hitch-hiked from Texas that day.

After I ceased talking to Larry Wilson, I did read him his rights at 12:25 AM, and he advised that he did not wish to give a statement and wanted an attorney. I ceased having any conversation at all with him at that time.

I made a preliminary examination of Larry Wilson and found that in addition to several dog bites and scratches on his lower torso, that he had a 2" laceration in the top center portion of his scalp, he had a 3/4" laceration to the forehead over the right eye and there was an accumulation of blood in the right neck area. It was later determined that he had a 1" laceration on the underside of the right bicep and that he had three small lacerations on the right neck and shoulder area. All these lacerations required stitches and this procedure was performed by Dr. Fred Moore.

At approximately 12:45 AM, Sgt. Ken East of the Violent Crimes, came to the Emergency Room and did attempt to question Larry Wilson after reading him his rights. I did hear Wilson say that a man and a woman in a Chevrolet had picked him up on the interstate and had brought him to Memphis and dropped him off, apparently on Highway 51, about a mile north of Wendy's. My notes do not reflect it but my recollection is that during the questioning by Sgt. East that Wilson had indicated that the color of the Chevrolet in which he came to Memphis was beige. Wilson carried on a brief conversation with Sgt. East and then told him that he didn't want to talk and that he wanted to see an attorney. Sgt. East immediately ceased questioning Wilson.

At approximately 1:00 AM, I was informed by the detention personnel that a M/W who had witnessed the shooting was in the Emergency Room and asked if I wanted to talk to this witness. I went around to the hospital waiting room and talked to Steve Craig, M/W, 19, 850 Dawn Dr., home phone 358-5803, who is unemployed and he advised me that he had been on Frayser Blvd, when the squad car with Stoddard and Parker had passed him. Steve Craig said that he knew Bob Stoddard from the past and that he followed the squad car and saw it pull onto the Wendy's lot. He said that he pulled onto the Holliday Auto Parts lot, which is just north of Wendy's and he saw a person whom he believed to be Lt. Oliver, walking behind a male/white later identified as Larry Wilson, north from the north side of Wendy's. He said that when they reached a point some distance from the north side of Wendy's, that the M/W began to run and Lt. Oliver pursued him several feet and jumped on his back in a bearhug. He said that they then fell to the ground and that Stoddard who had approached the scene, joined in the struggle. He said that as he watched, he saw a muzzle flash and saw Ptlm. Stoddard knocked backwards several feet and lay on the ground. He said that the suspect, Larry Wilson, then pulled the trigger of the gun several times in succession and he believed that it was about the third bullet fired by the defendant which struck Lt. Oliver. He said that he only saw this as he was getting down behind his vehicle and he didn't see Lt. Oliver ever fire his weapon. I advised Steve Craig to stand by, that we would need for him to review a possible line-up to be conducted later this morning, and that we would need a written statement from him.

Antoinette Law, FW, 19, who identified the defendant as being the person responsible for the armed robbery. This identification was made at 4:05 a.m. An Oldsmobile key ring with two keys on it was taken from Ms. Law by the defendant and subsequently found in his possession. This key ring was initially tagged as evidence but later released to Ms. Law and a photograph taken of Ms. Law and her key ring. A typed and signed statement referring to the identification of the defendant and the receipt of her property is attached.

A typewritten and signed statement concerning the events of the armed robbery and the subsequent shootings is attached. Garvin T. Hall, MW, 19, residence 1953 James Road, home phone 358-4107, employed at the Memphis Louvre Company, phone 464-6183. At 4:30 a.m. Ptlm. W. H. Arnold, assigned to the GIB office, midnight shift, obtained a typewritten and signed statement wherein Mr. Hall identified the defendant as the person he saw running from the scene of the armed robbery and the shooting. This statement is attached. This is a tentative identification.

Steve Burks, MW, 30, residence 3203 W. Thomas, Apt. 8, phone 358-1427, employed by Wendy's, phone 353-3148. A typewritten and signed statement was obtained from Mr. Burks at 4:45 a.m. in which Mr. Burks stated how he activated the silent holdup alarm and the events following the robbery. Mr. Burks also identified the defendant as the male white that robbed Wendy's.

Jeff Rickard, MW, 19, residence 1842 St. Elmo, phone 358-1429, employed by the Memphis Louvre Company, phone 454-6183. At 5:00 a.m. a typewritten, signed statement was taken by Ptlm. W. H. Arnold of the GIB office midnight shift. Mr. Rickard could not identify the defendant as the male white he saw running with his hand to his head and a gun in his left hand from the scene of the holdup. This statement is attached.

Kerry Scott Kill, MW, 19, residence 2116 Colfax, phone 345-0793, employed by C. E. Meyer Carpet Cleaner. A typewritten and signed statement was taken at 5:45 a.m. in which Mr. Kill identified the defendant as the person that robbed Wendy's at gunpoint. See attached statement.

The three witnesses that are not employees of Wendy's are: Steve L. Craig, MW, 19, address 890 Dawn Drive, phone 358-5803, unemployed; at 5:25 a.m. a typewritten, signed statement was obtained by Ptlm. W. H. Arnold of the GIB midnight shift. Mr. Craig identified Larry Wilson as the man he saw wrestling with Lt. Oliver and Ptlm. Stoddard. Mr. Craig also observed Larry Wilson shoot Ptlm. Stoddard in the arm and then heard six more shots and observed the Lt. Oliver lying on the ground. See attached statement.

Leonard Hood, MW, 42, residence 963 Frayser Circle, phone 353-2520, self-employed. At 4:05 a.m. a typewritten and signed statement was taken by Ptlm. W. H. Arnold of the GIB midnight shift. Mr. Hood stated that he saw a man hide beside his truck and Mr. Hood then hollered for a police officer to come to the house. Mr. Hood identified the defendant Larry Wilson as the person he saw hiding by his truck. Mr. Hood also observed the defendant give himself up to the police. This is a tentative identification.

Ptlm. S. G. Parker, MW, home address 3538 Pueblo, phone 157-2073, North Precinct Uniform Patrol, C Shift. At 2:10 a.m. on August 6, 1981 a typewritten, signed statement was taken by Ptlm. W. H. Arnold in which Officer Parker identified the defendant as the subject he saw shoot Officer Stoddard and then flee the scene. The defendant also fired his weapon at Officer Parker. See attached statement.

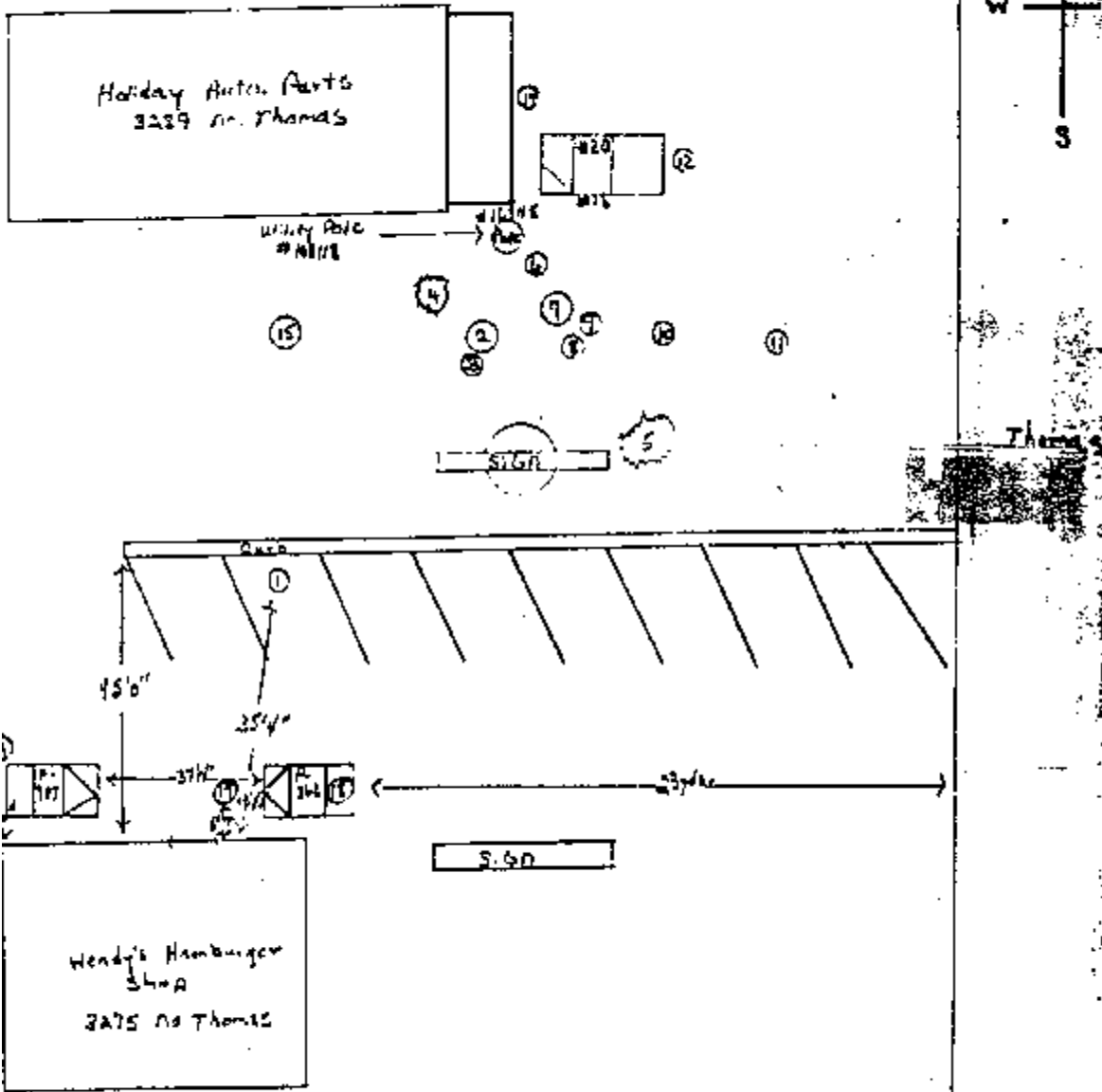
