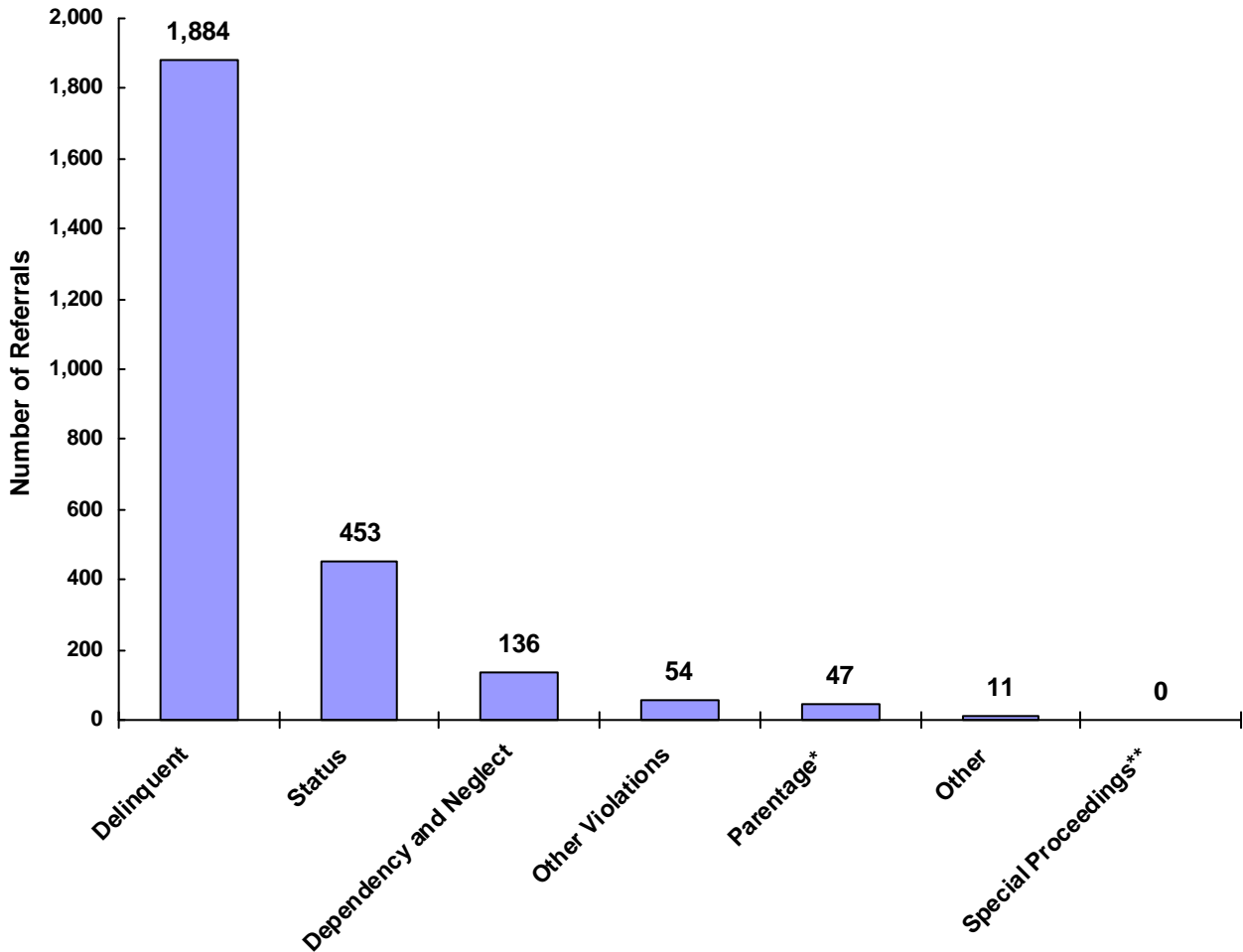

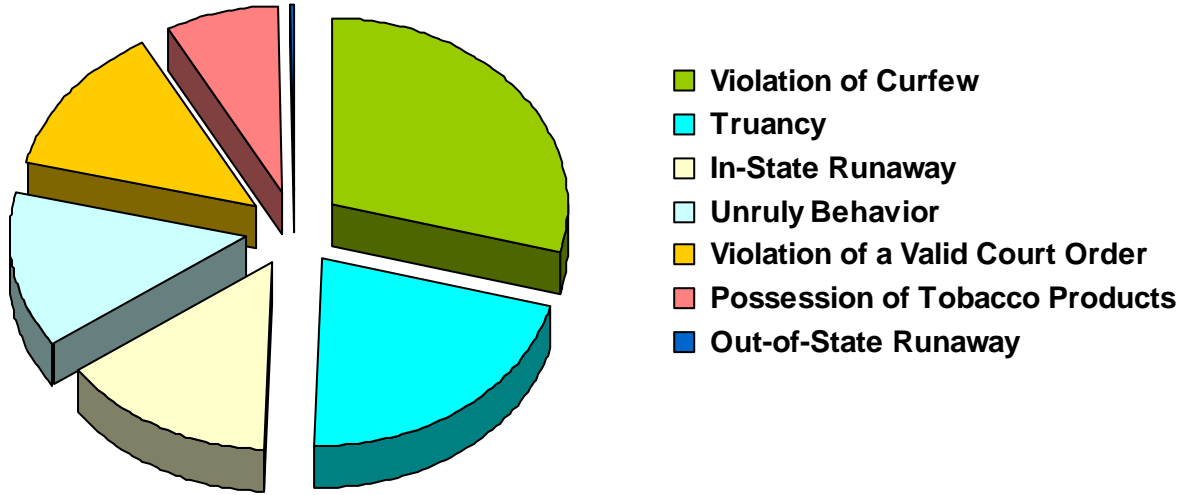

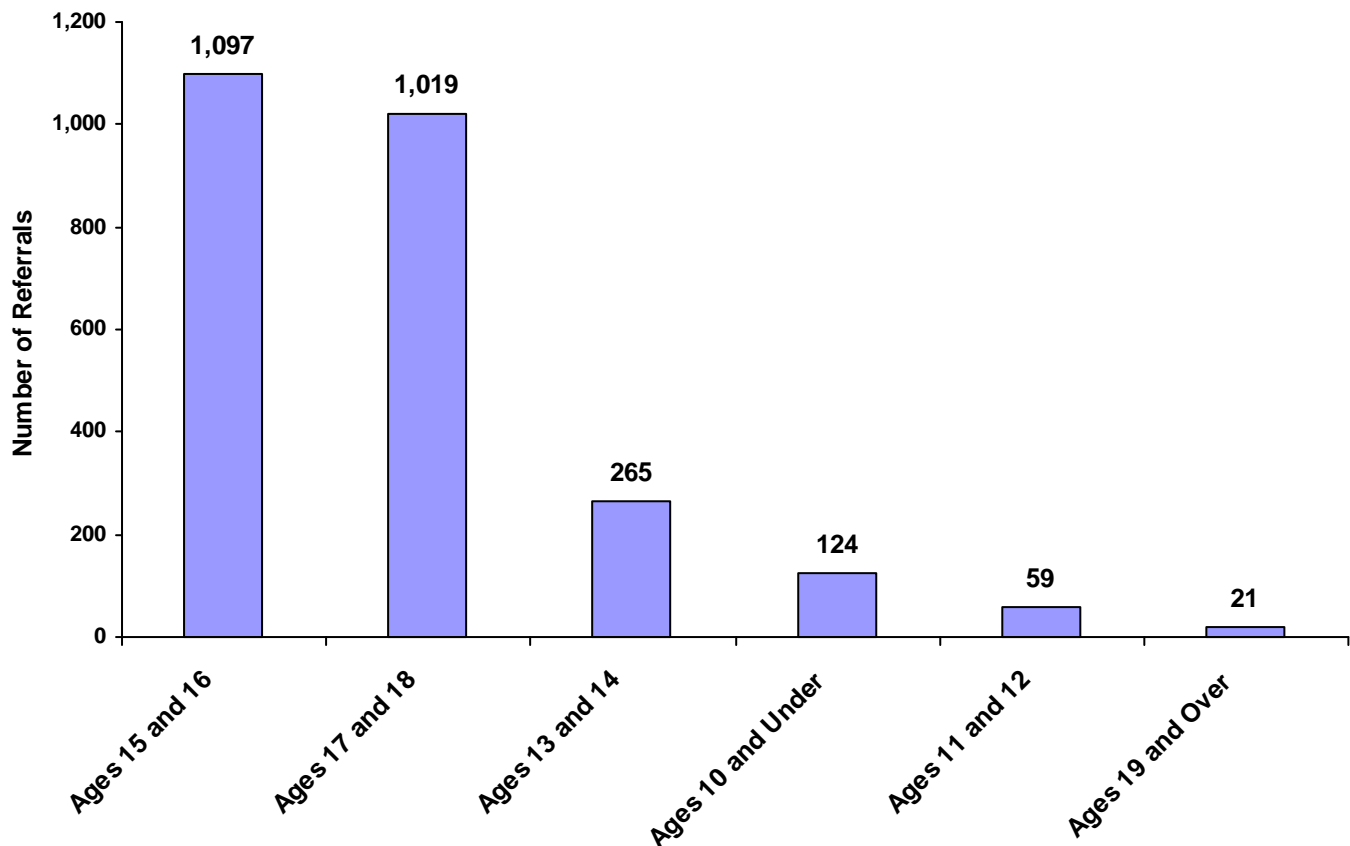

**Total Referrals by Age Group**

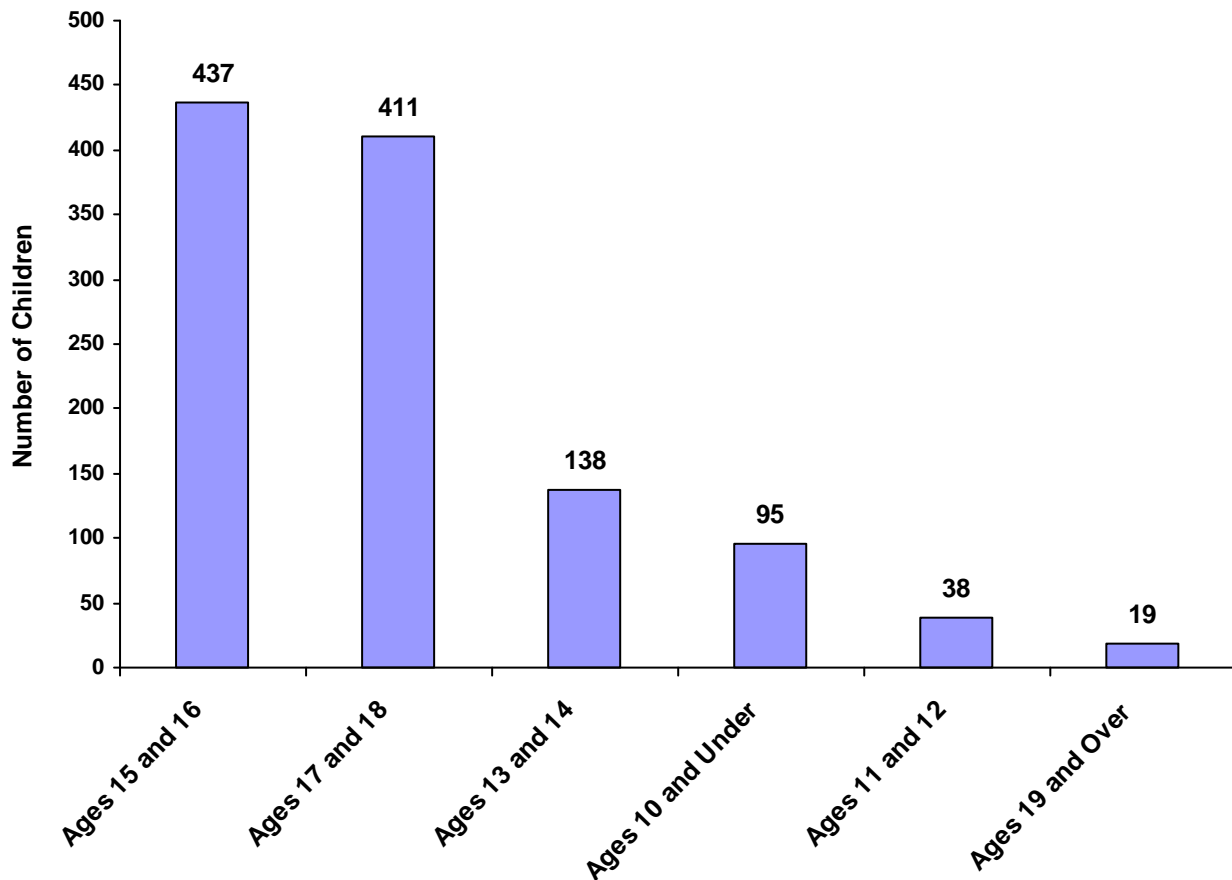

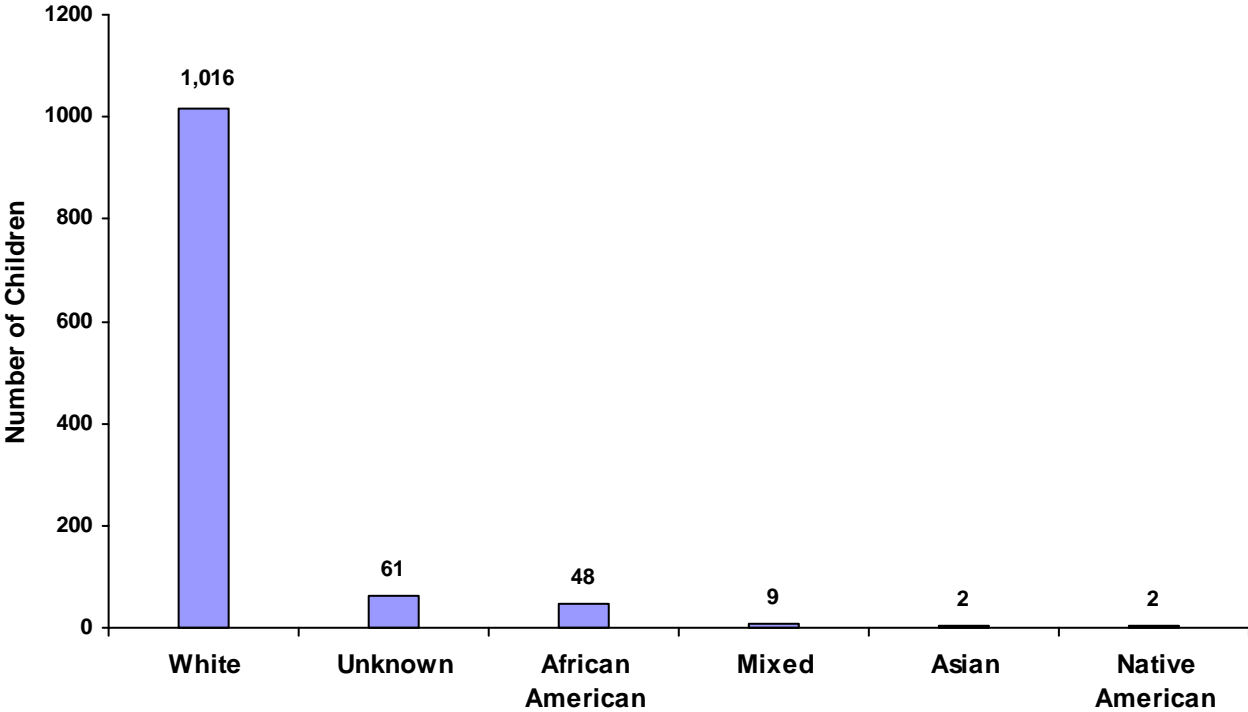

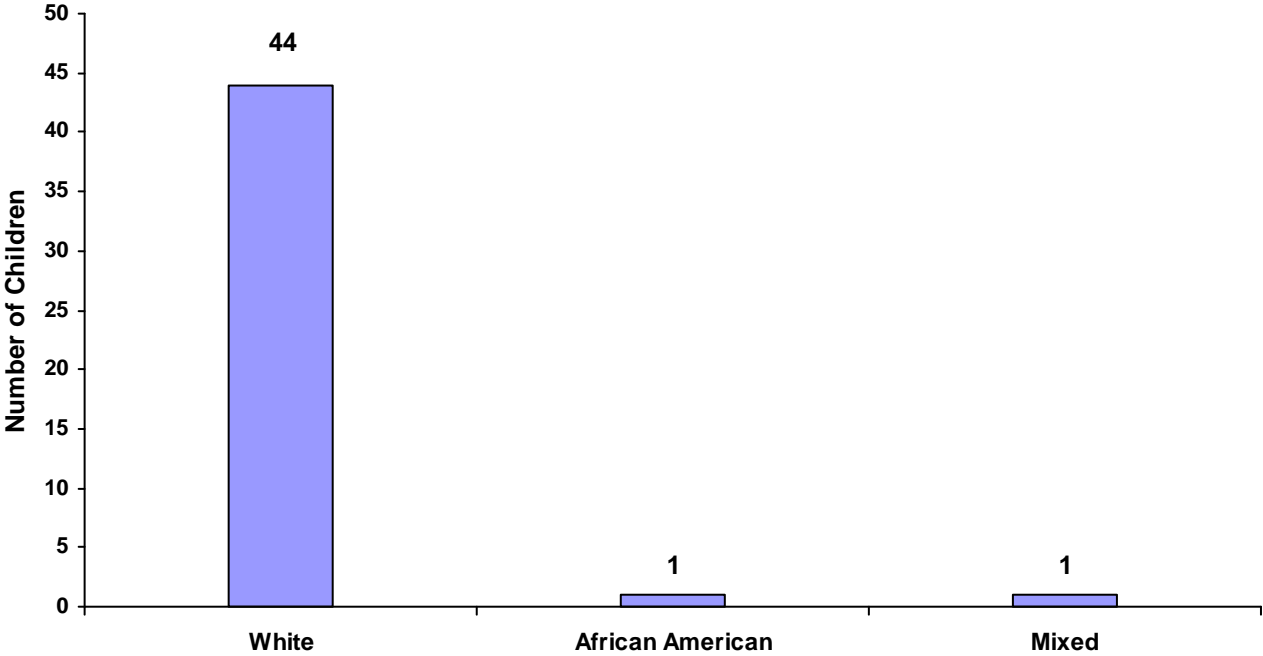

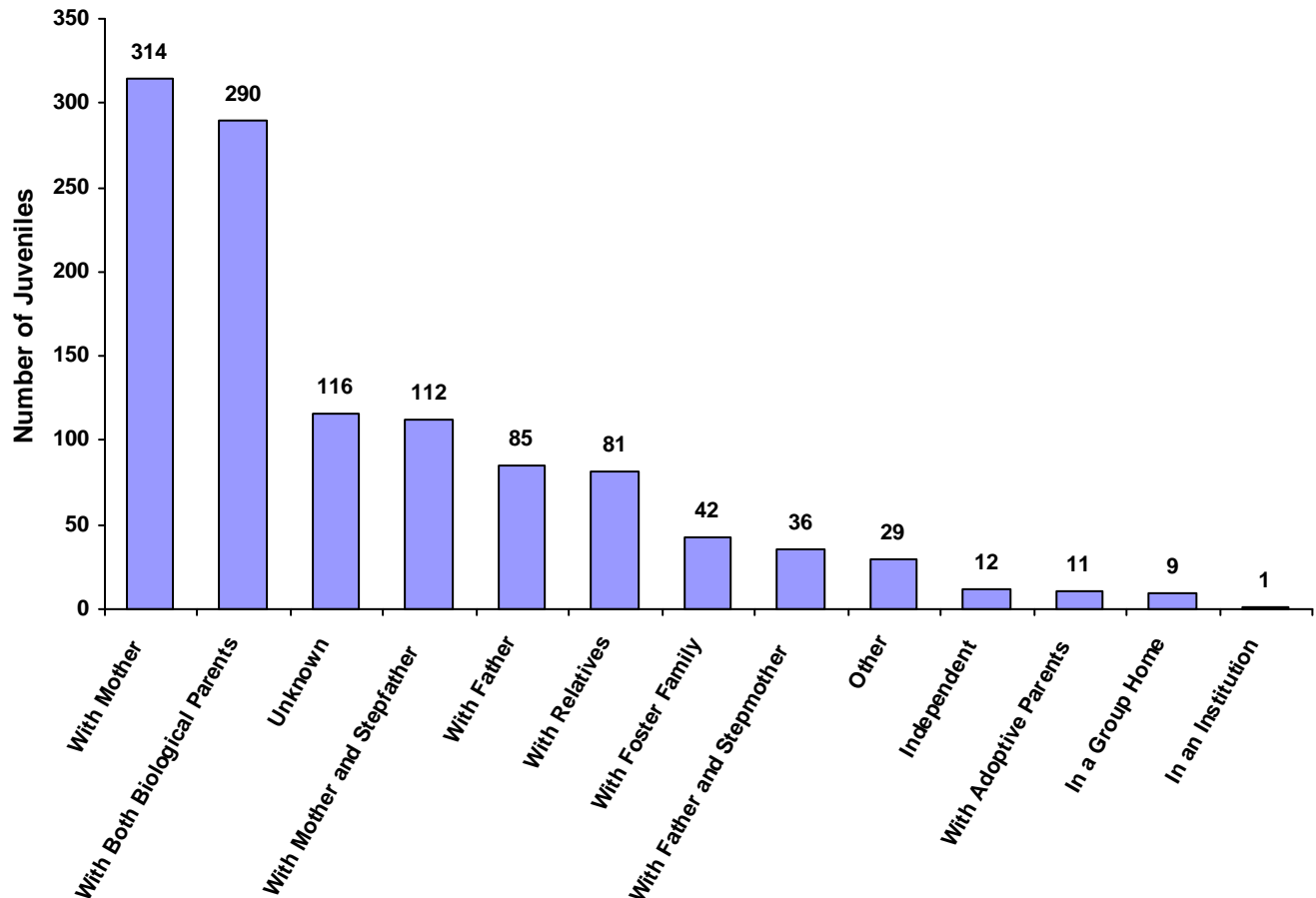

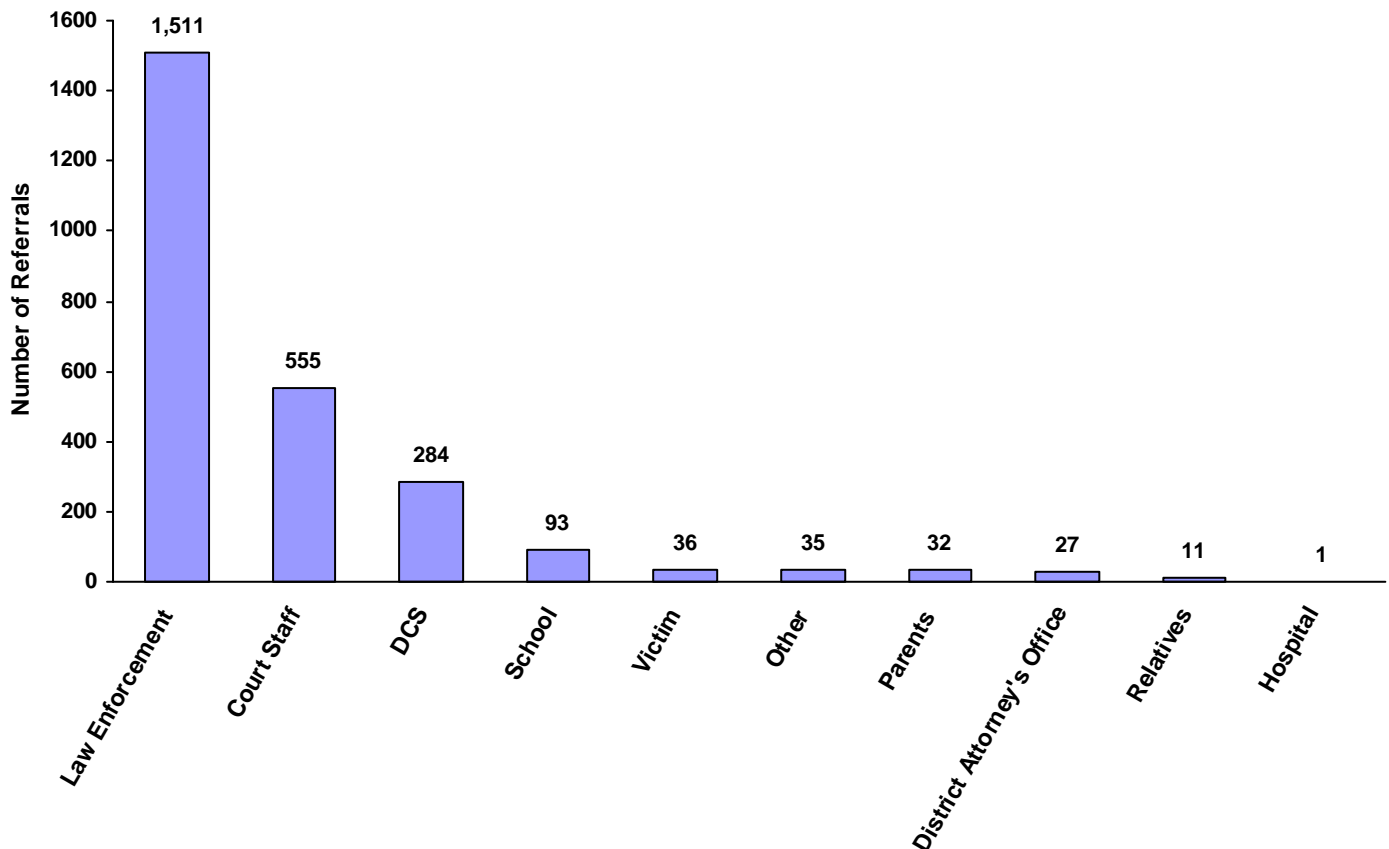

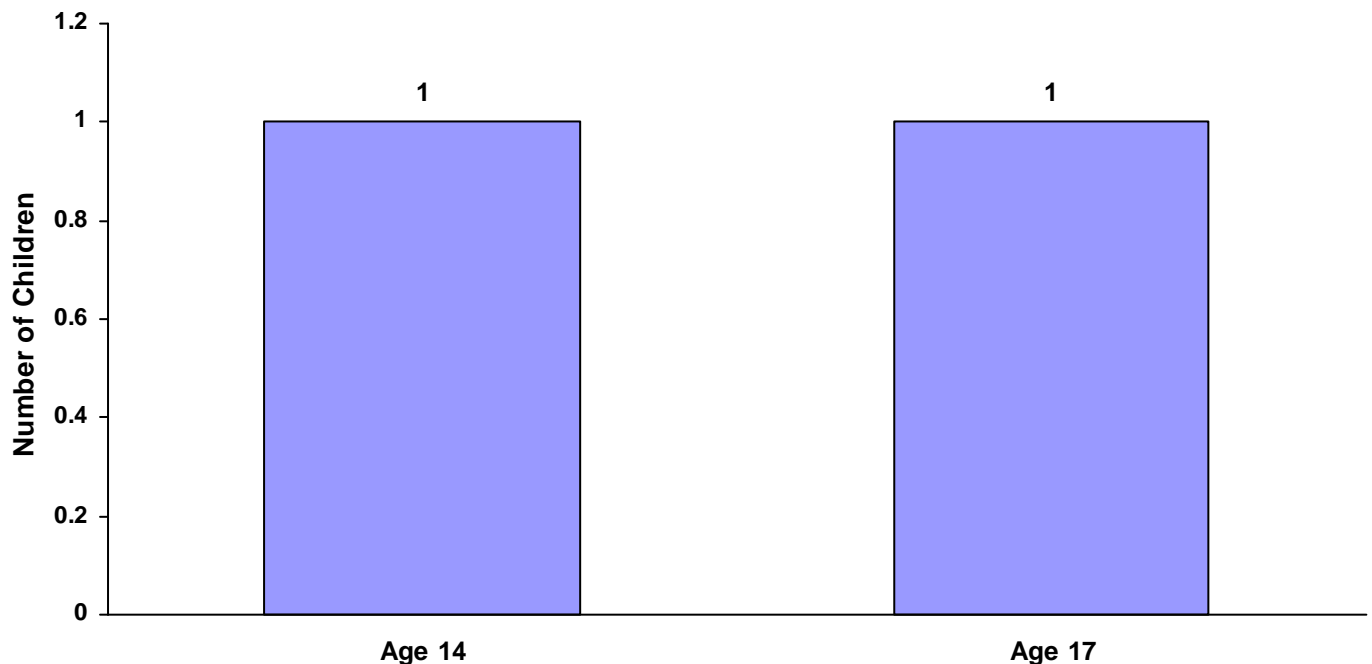

**Total Children Referred for Unlawfully Carrying/Possessing Weapons**



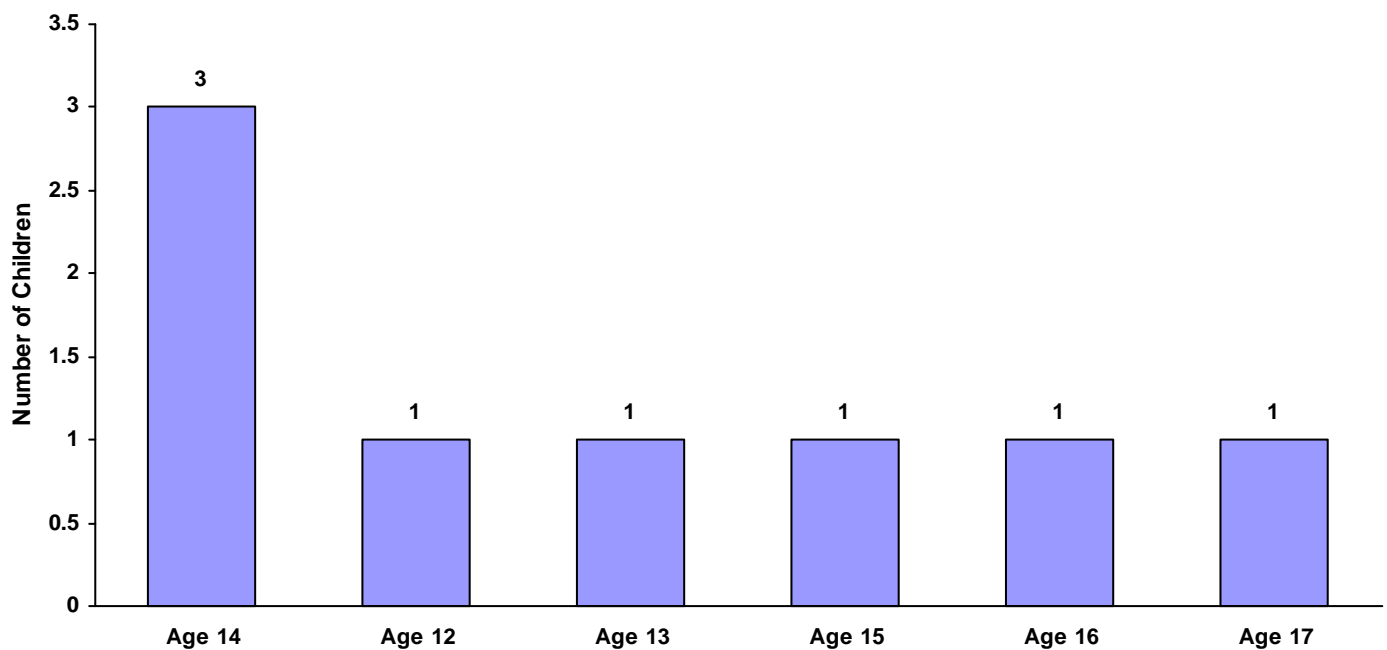

**Total Children Referred for Carrying Weapons on School Property**

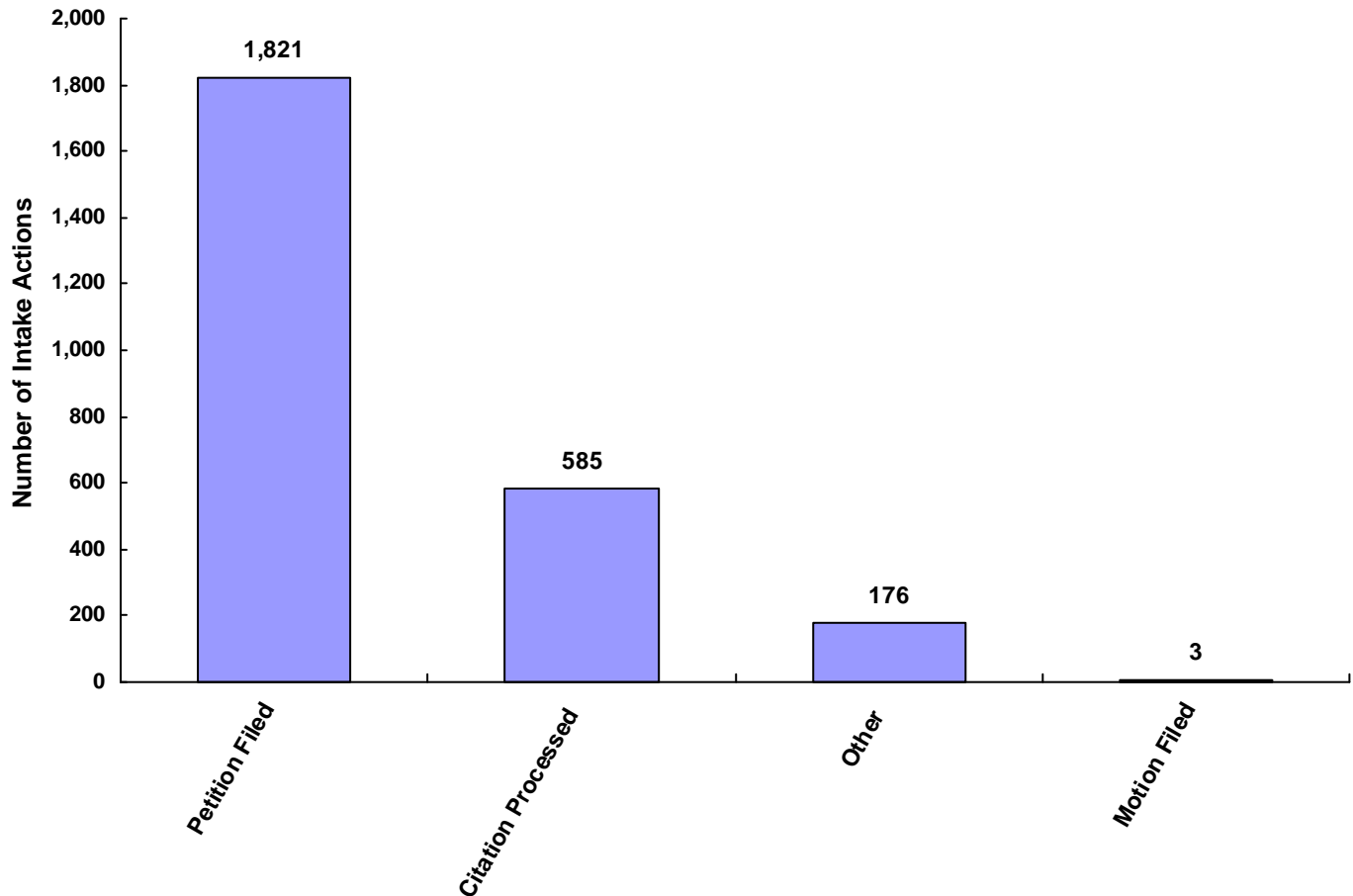

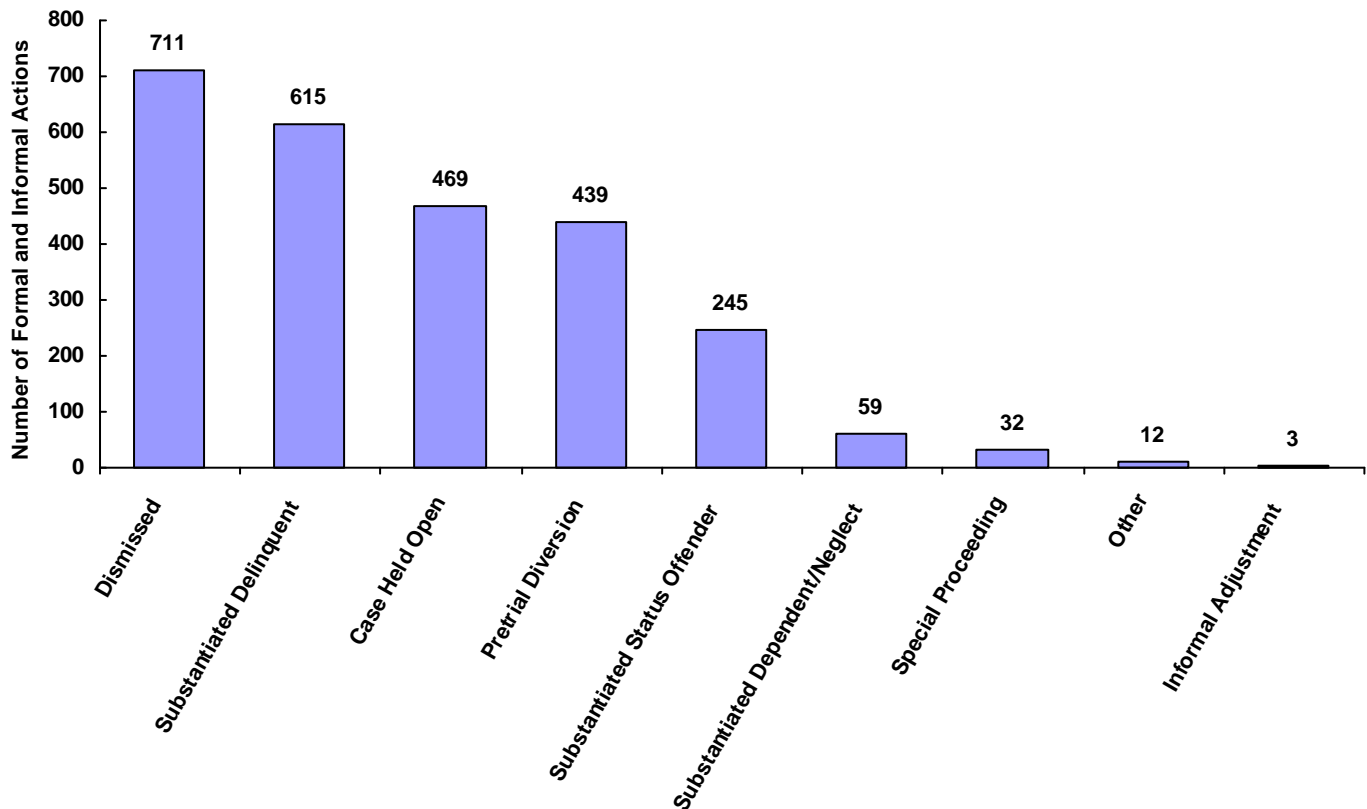

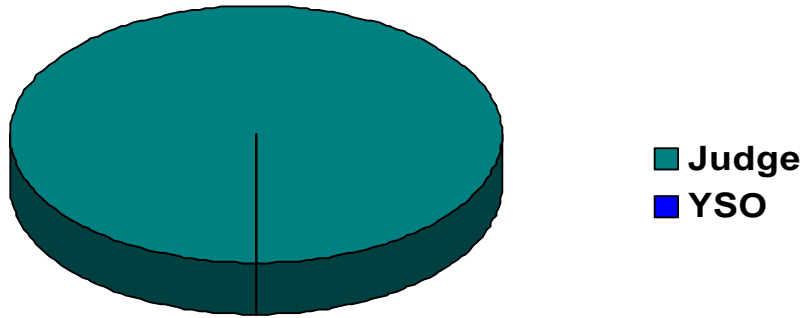
