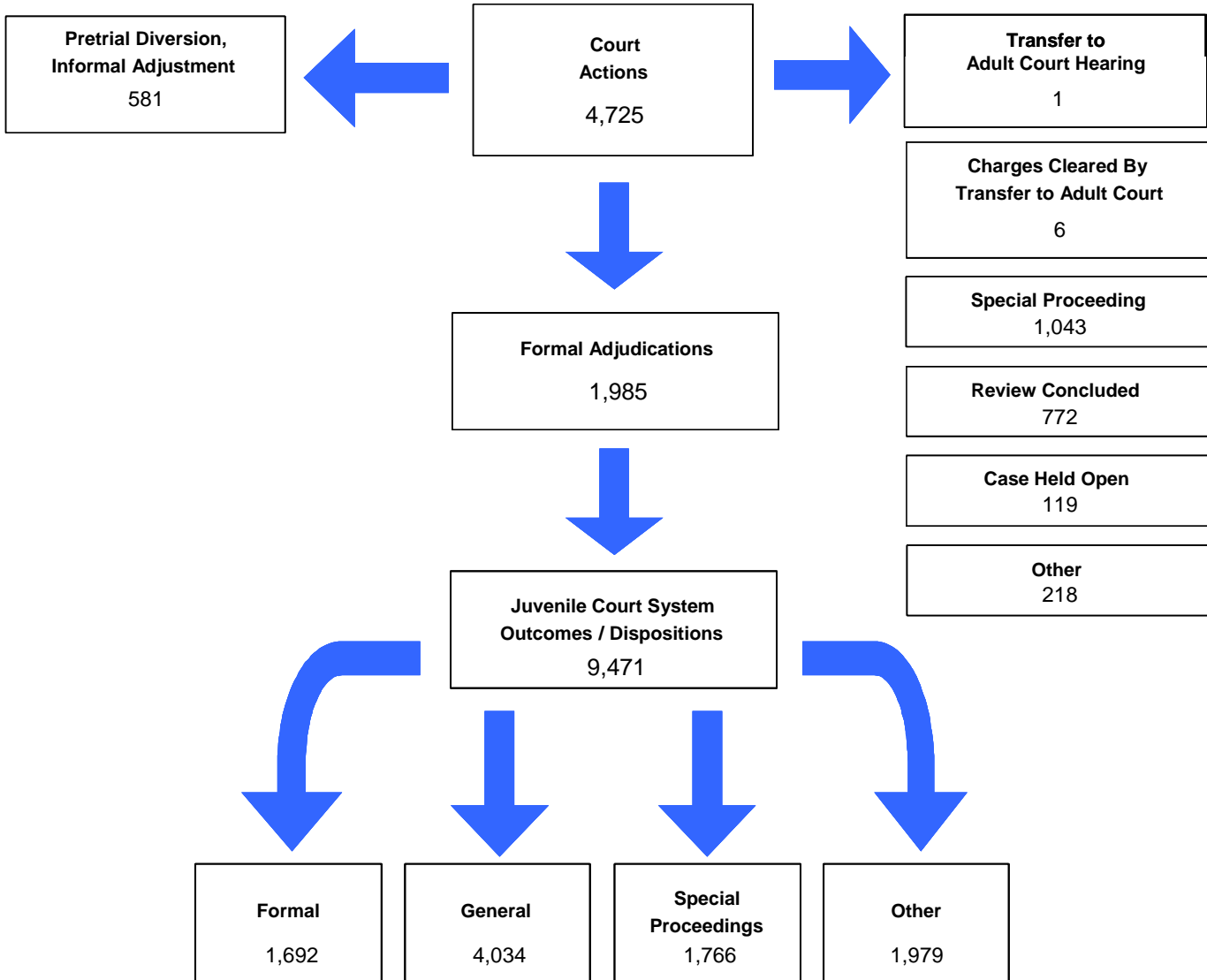

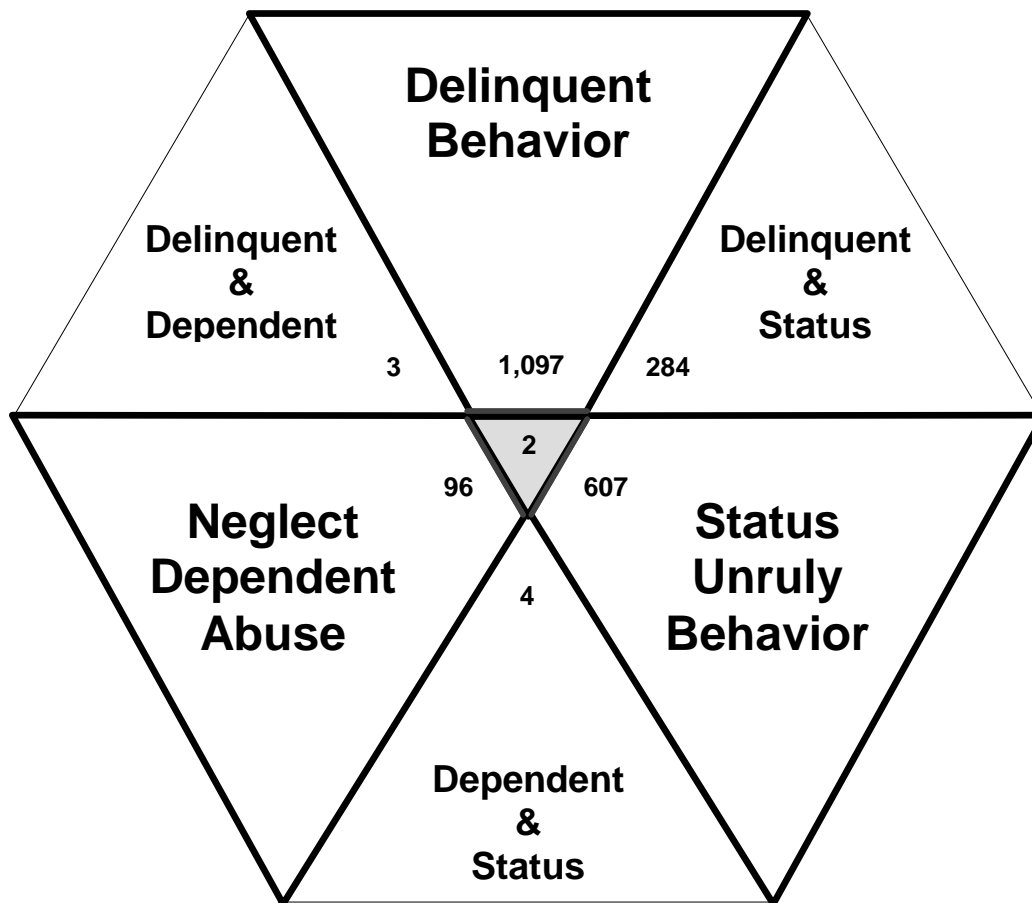

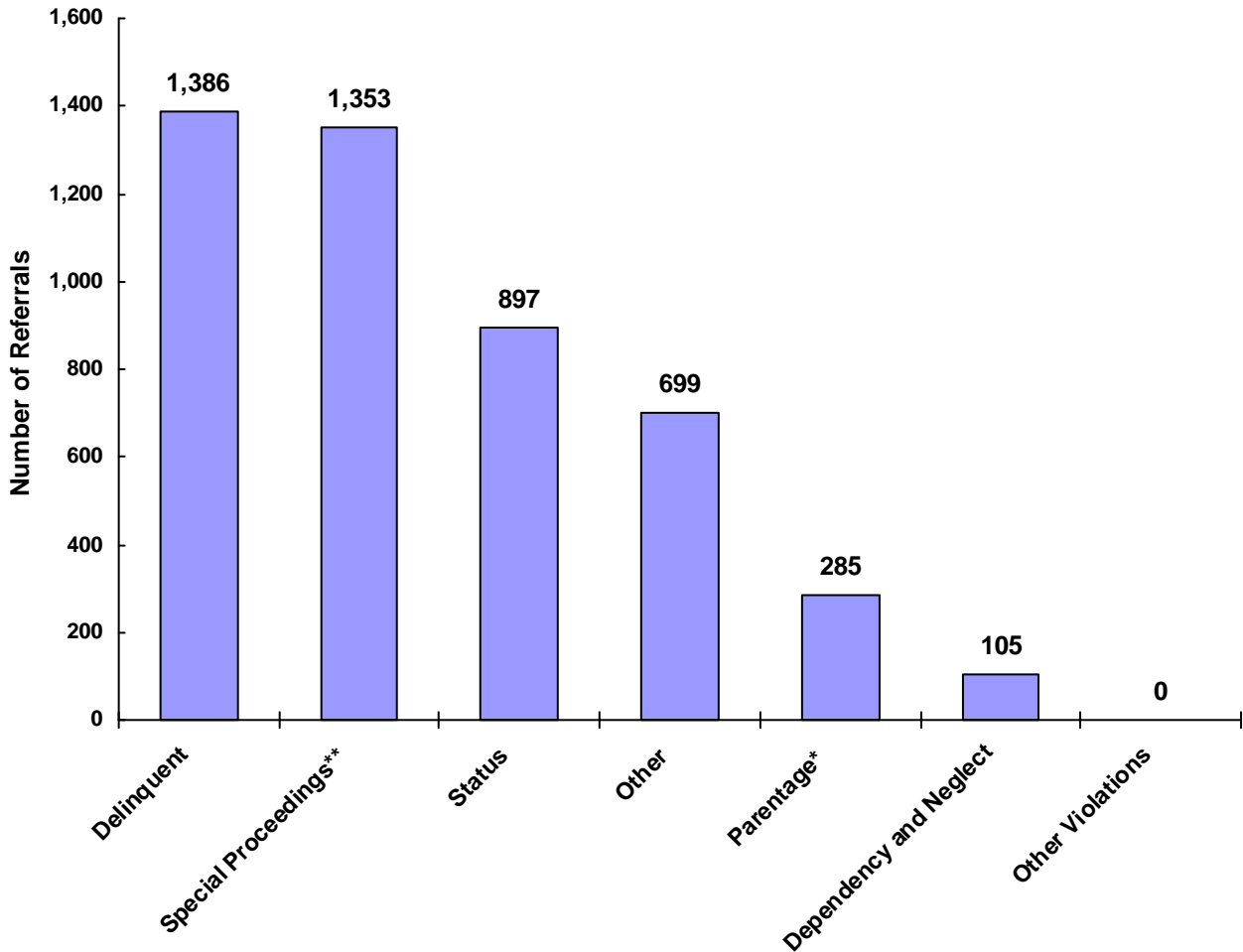

Children can have referrals in multiple categories. The drawing above shows that in the year 2008 there were 1,097 referrals to Sumner County Juvenile Court for children with only delinquent offenses, 607 for those with only status/unruly behavior, and 96 for children with neglect, dependent or abuse referrals during the calendar year. There were 284 referrals for children that had a delinquent AND a status/unruly referral. There were 3 referrals for children with both delinquent behavior AND a neglect, dependent or abuse allegation. There were 4 referrals for children that had both a status/unruly referral AND a neglect, dependent or abuse allegation. Also, there were 2 referrals for children that had a delinquent referral, a status/unruly referral AND a neglect, dependent or abuse allegation.

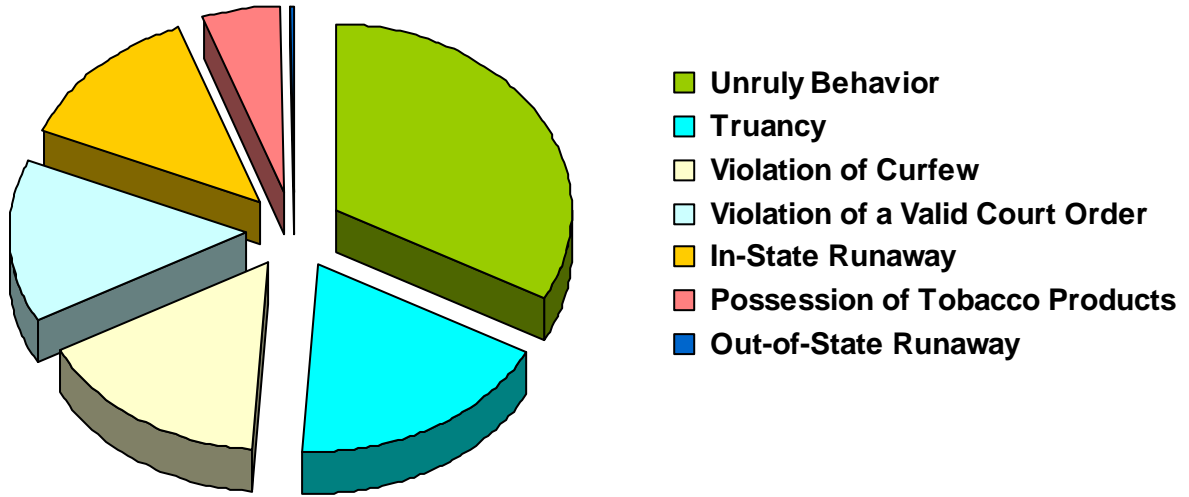

A Status offense is an offense committed by a child that if committed by an adult, would not be considered an offense or unlawful act. An example of this is smoking when not legally an adult.

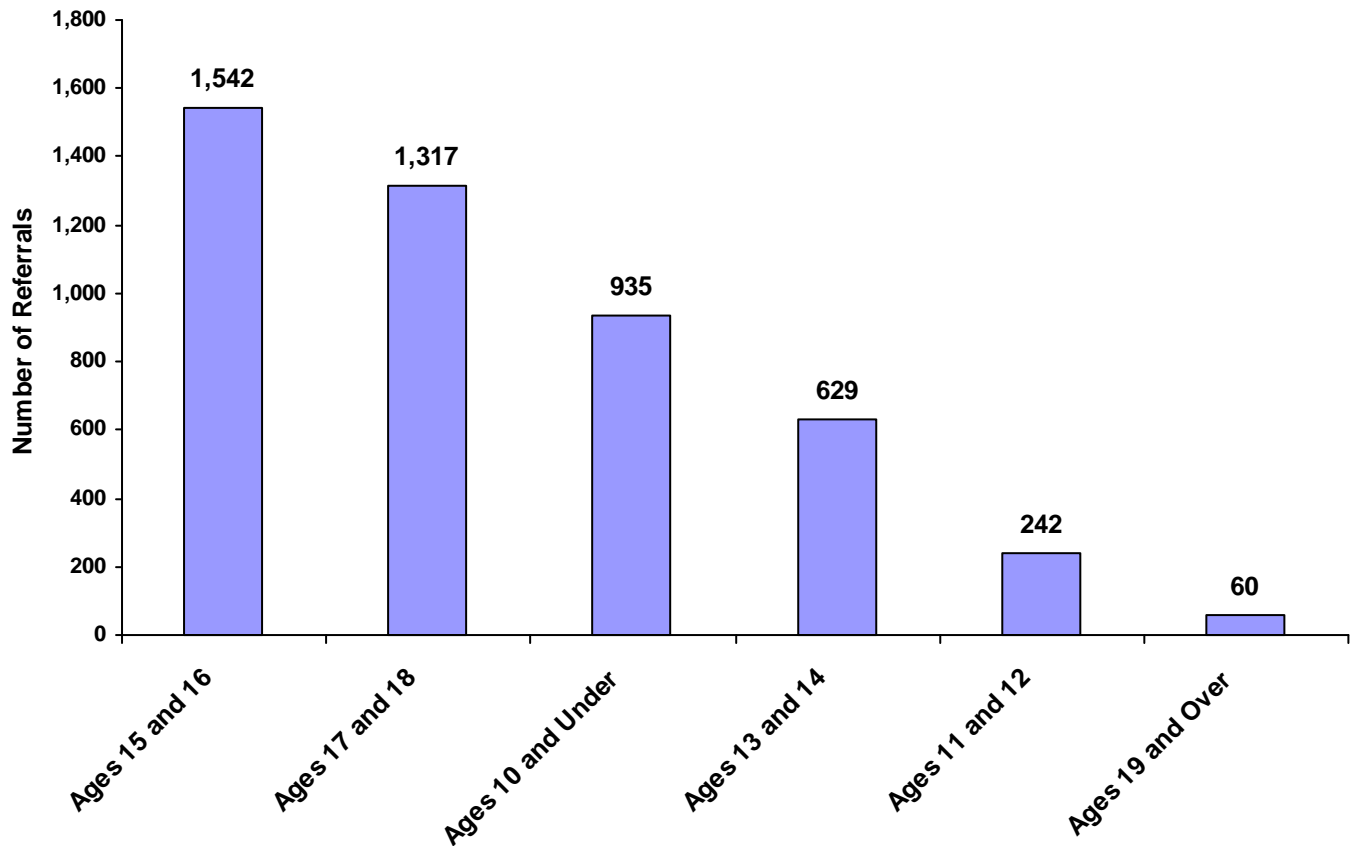

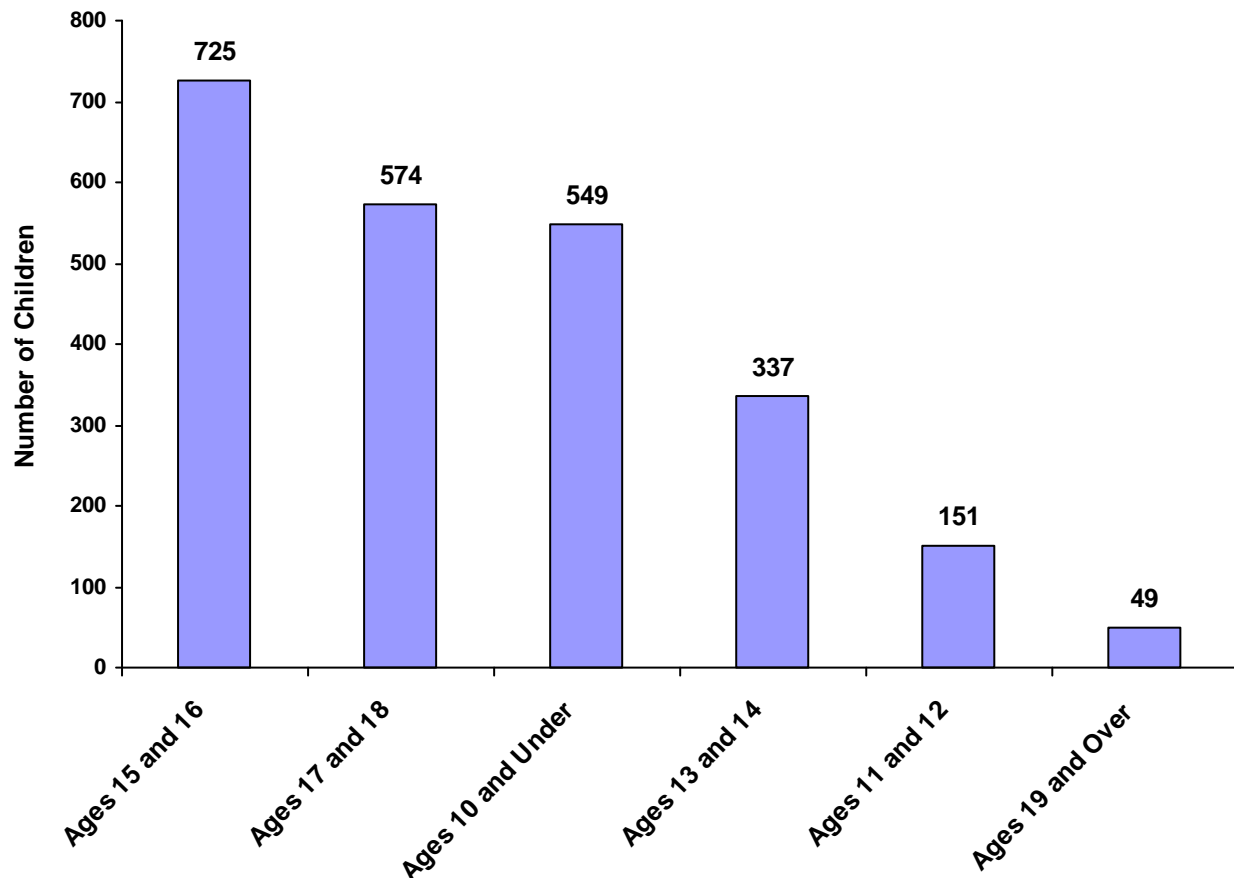

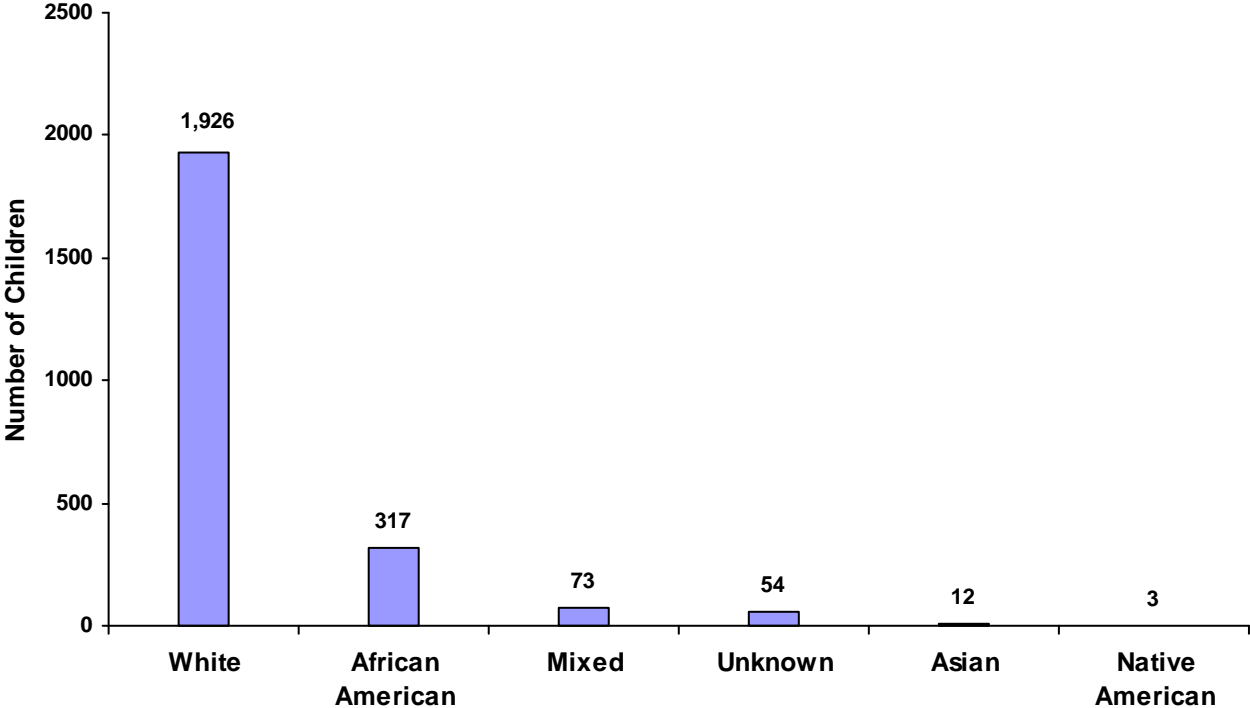

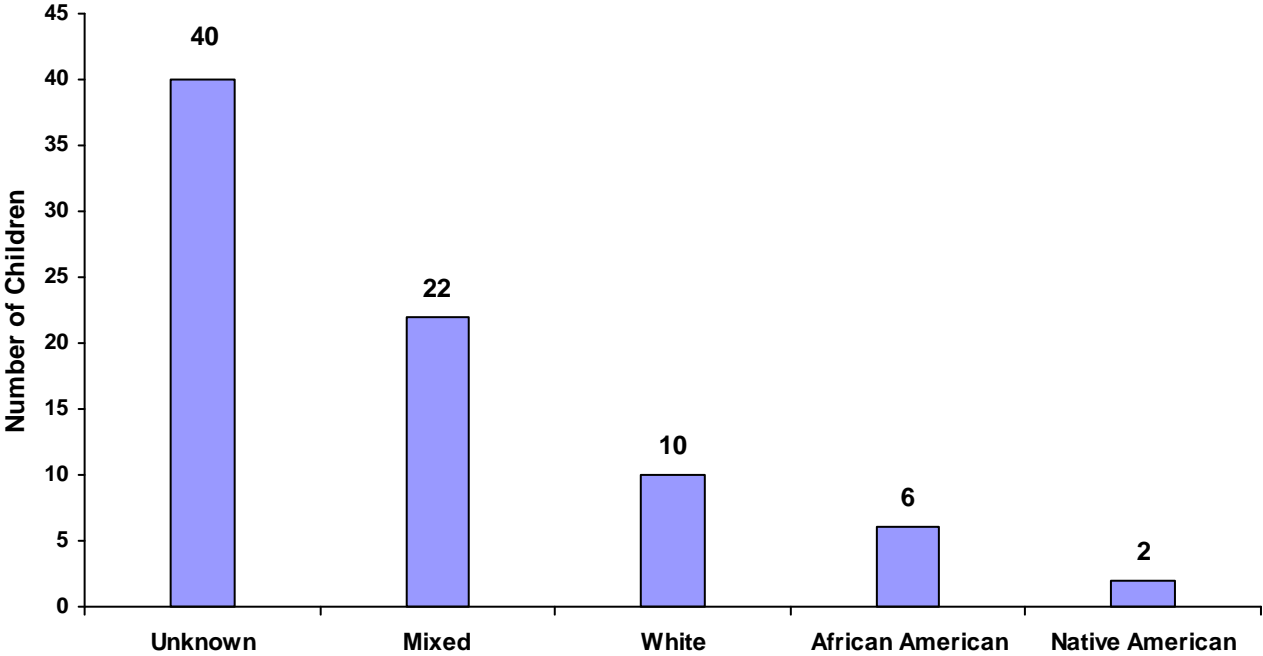

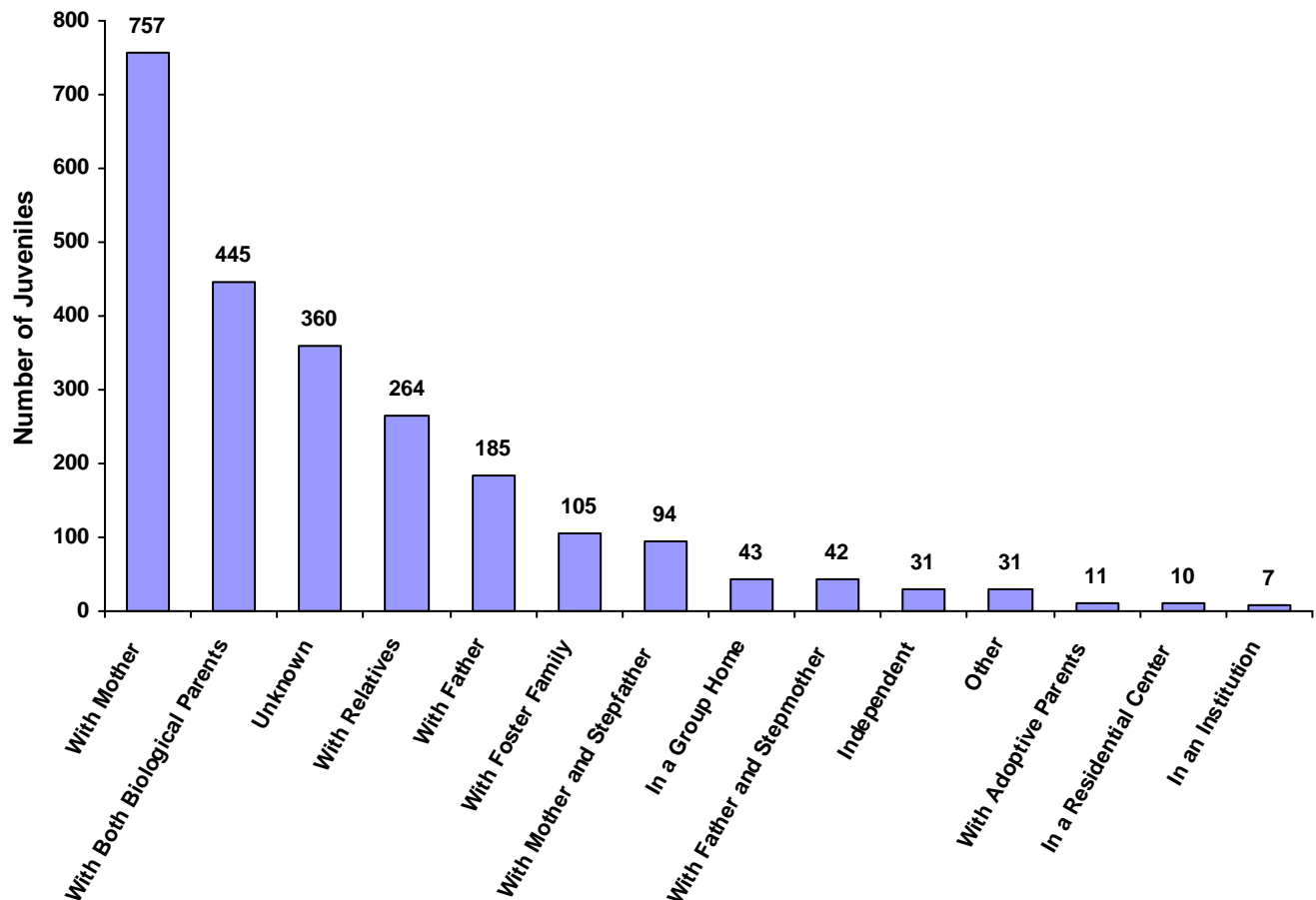

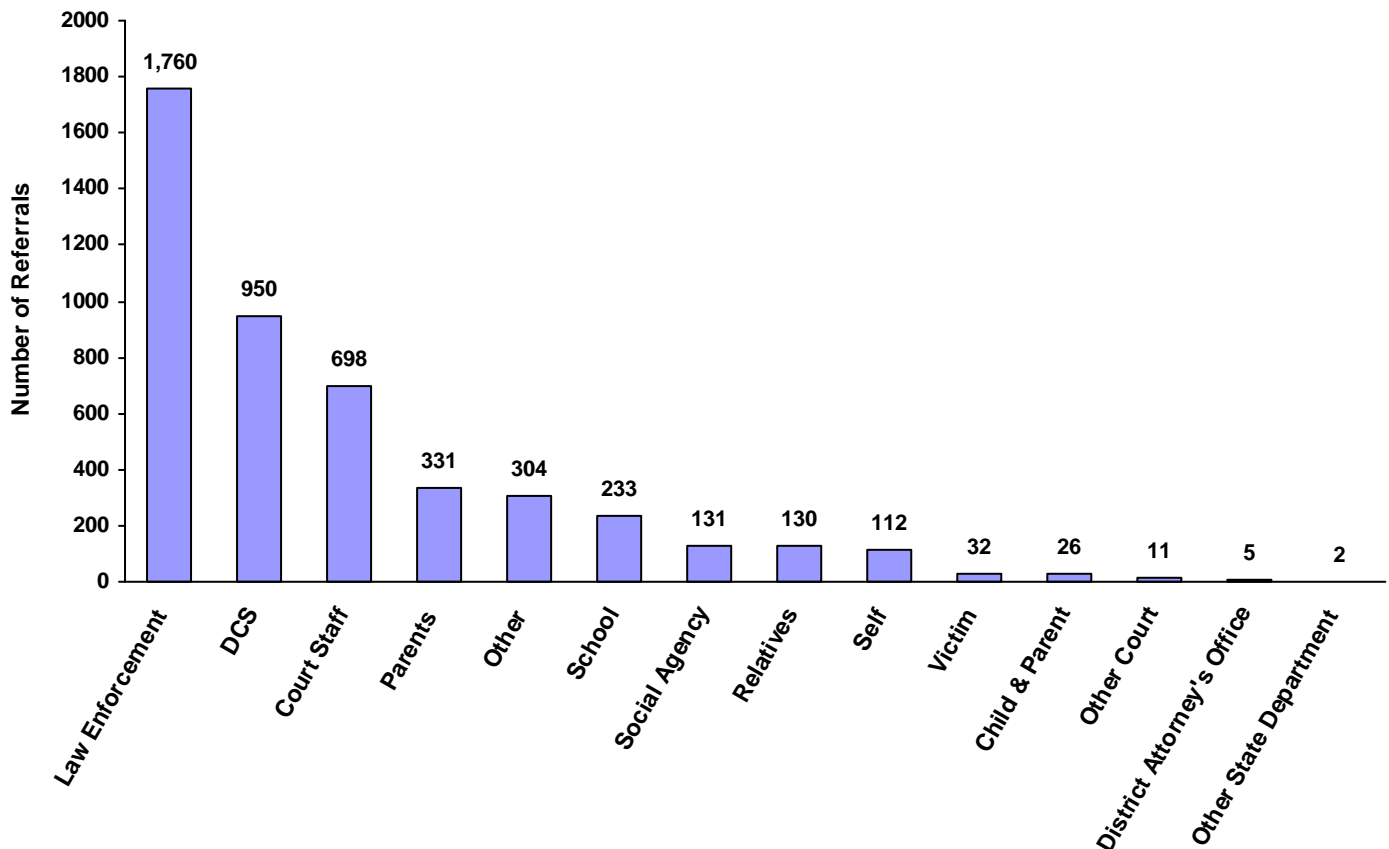

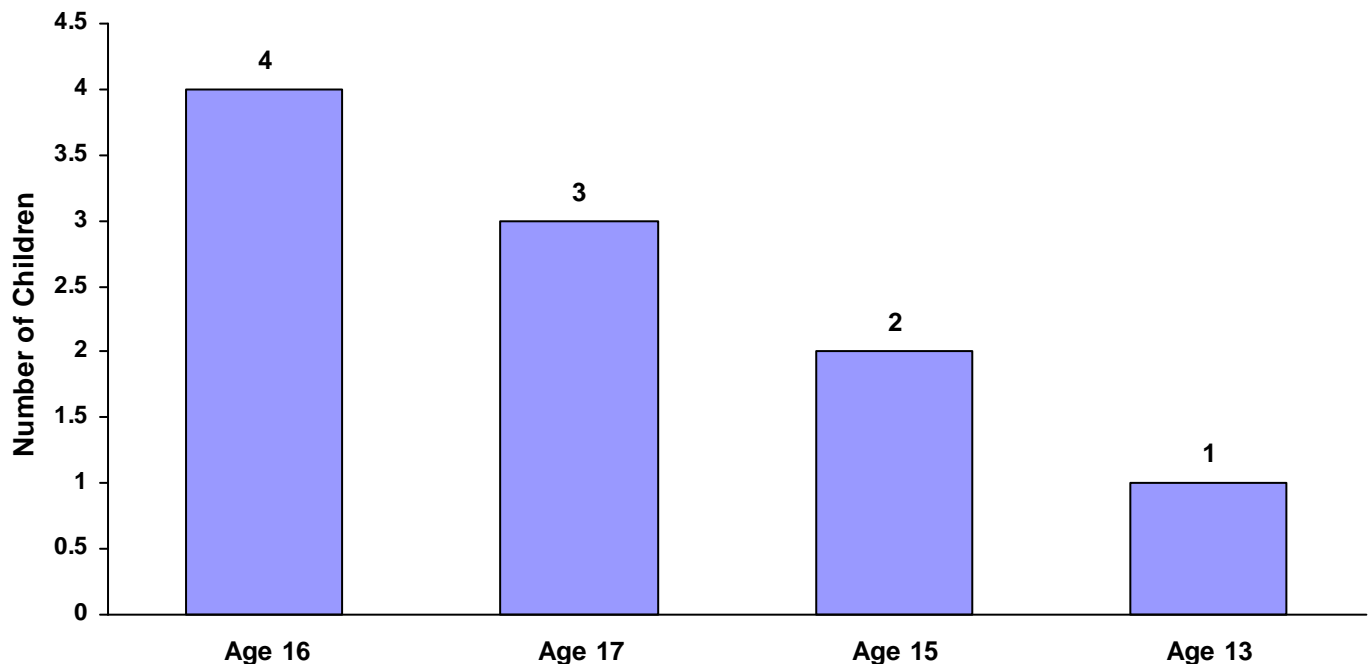

Total Children Referred for Unlawfully Carrying/Possessing Weapons



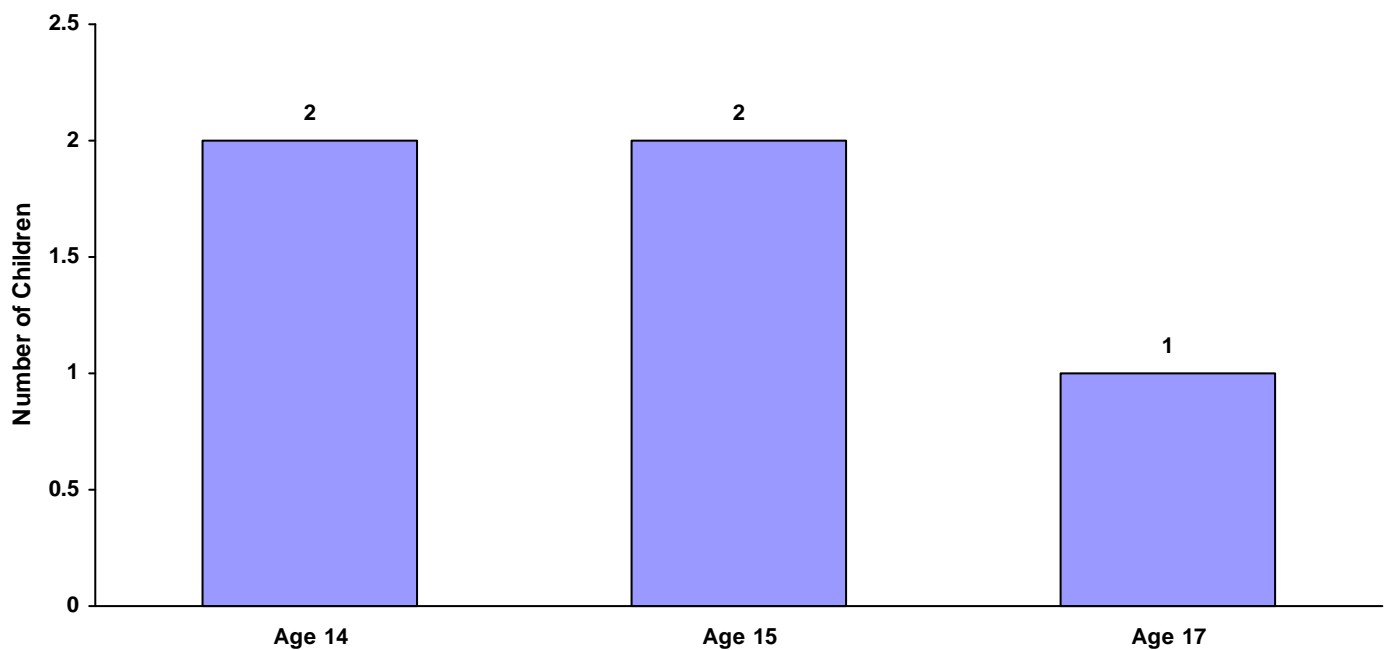

Total Children Referred for Carrying Weapons on School Property

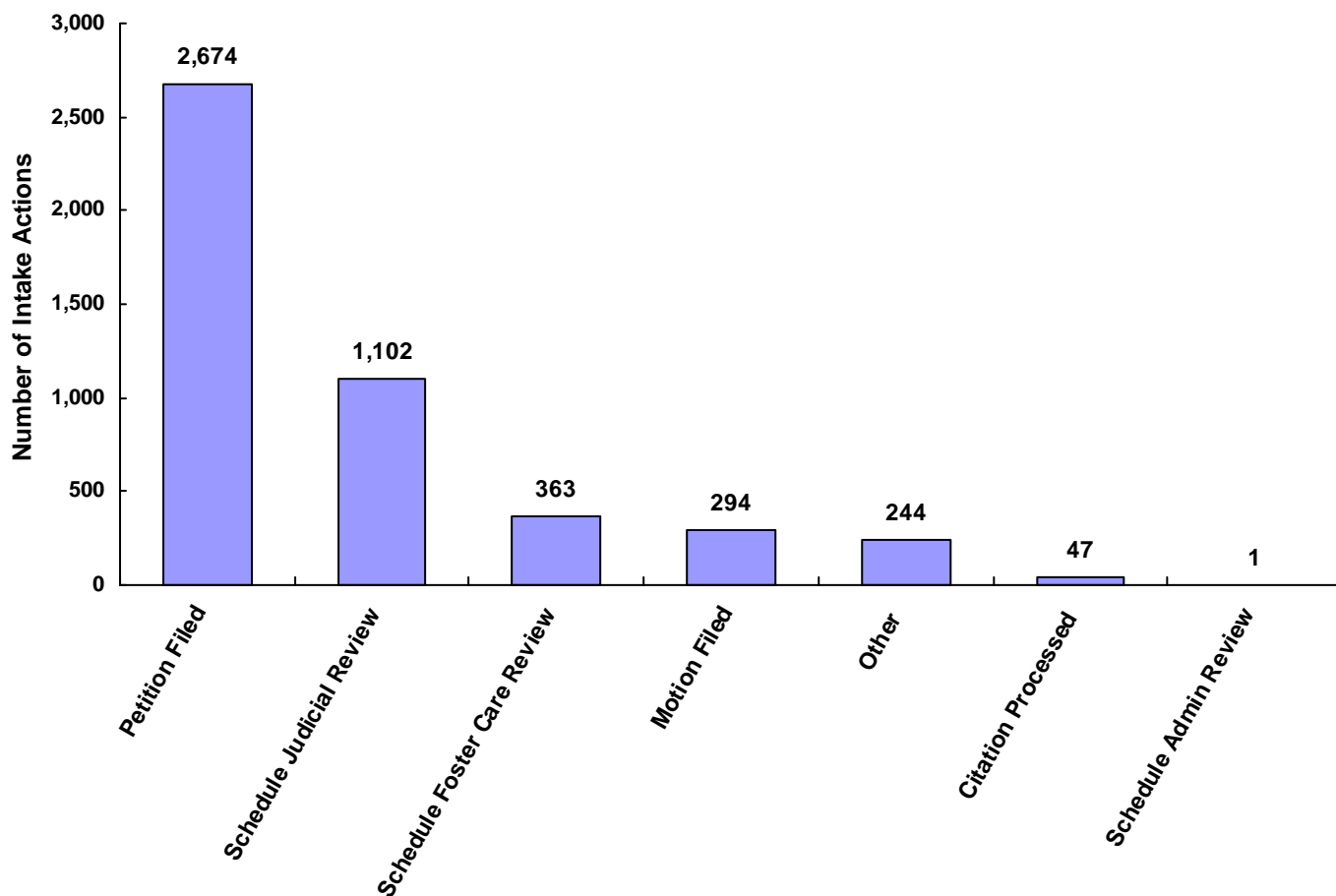

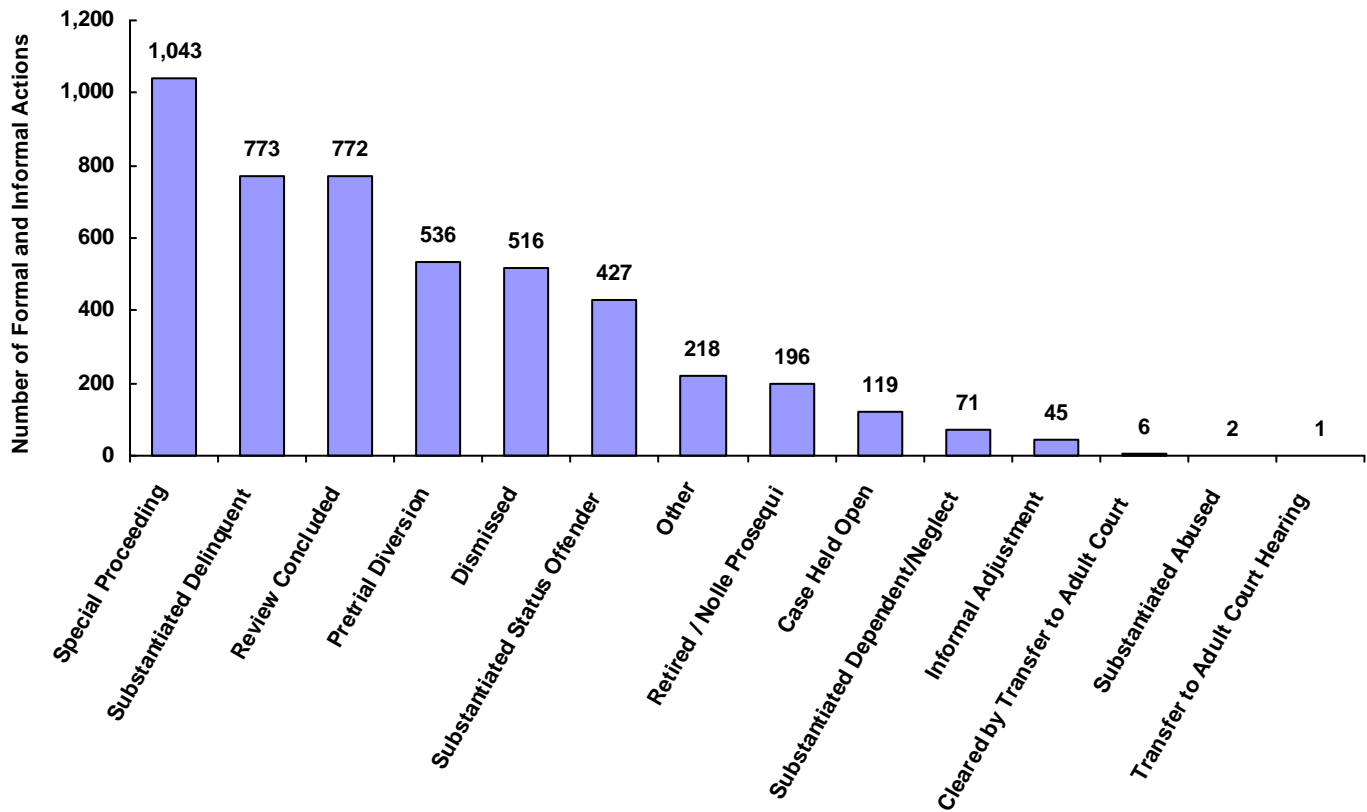

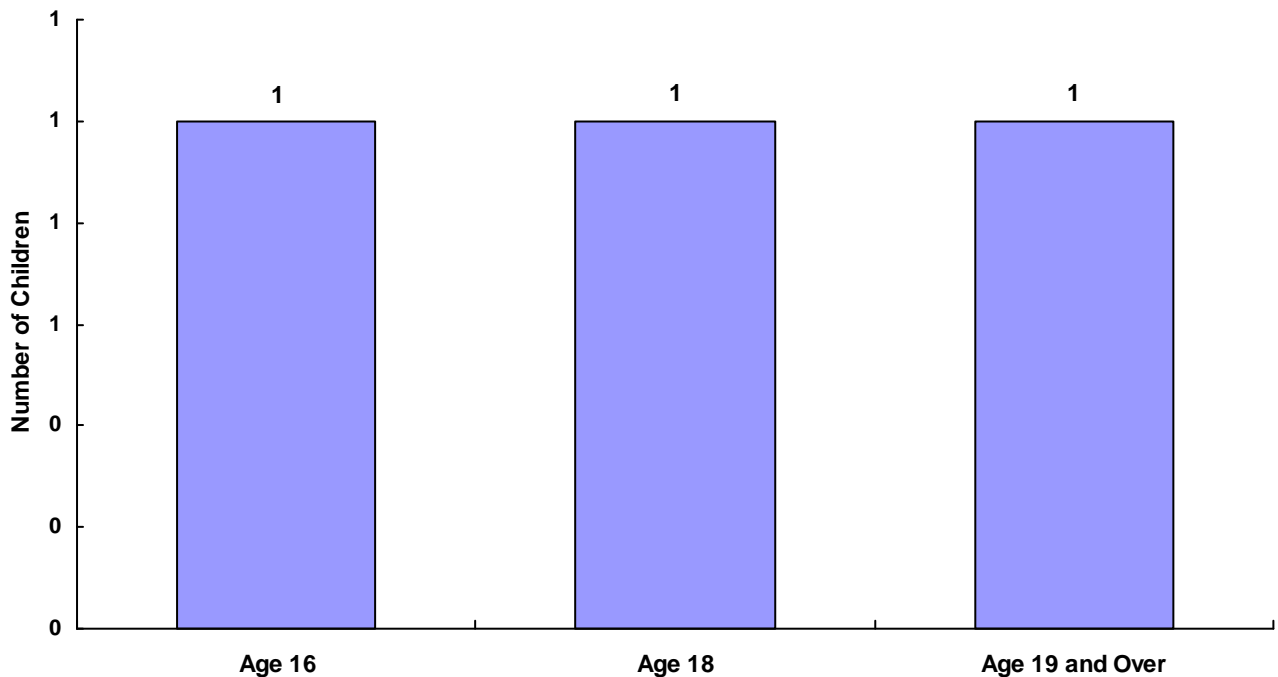

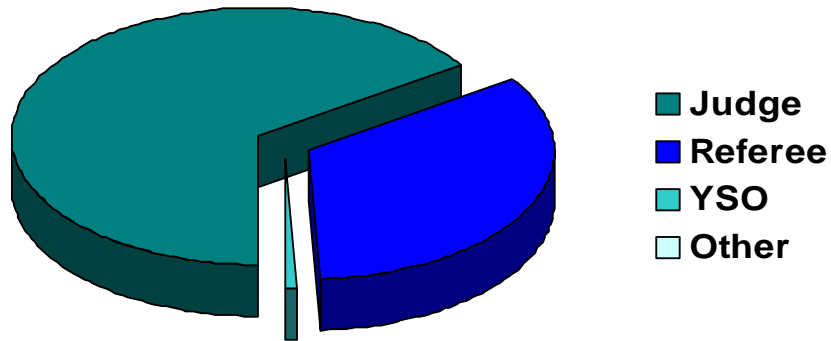
