### **MEMORANDUM**

**RE:** Administrative Fee for Appointed Counsel

In 1997 the Tennessee General Assembly enacted Public Chapter 547 (T.C.A. 37-1-126 and 40-14-103) providing for the assessment of an administrative fee on all indigent criminal and juvenile delinquent defendants who are provided court appointed counsel. Court appointed counsel includes public defenders and private attorneys. The public chapter authorized an administrative fee between \$50 and \$200 per defendant. A separate law, Public Chapter 857 also requires the collection of additional data in cases in which a guardian ad litem is appointed in a juvenile dependency or neglect case.

The law specifically requires court clerks to submit monthly reports to the Administrative Office of the Courts. These reports contain the following information: the number of defendants appointed counsel and/or guardian ad litem, the number of cases in which a fee was assessed, the number of cases in which the fee was waived, and the dollar amount collected by the clerk's office and submitted to the Department of Revenue. The attached status report contains information received from the court clerks for calendar year 2017.

As we reported last year, due to a change in computer systems, Shelby County Criminal court fee data was not available for November and December 2016. We have continually contacted the clerk's office over the past year to request this statutorily required data be filed. I have included an email response sent from Shelby Criminal Court explaining the delay in the report's appendix.

We have also included several graphs and tables in this appendix in order to provide a year-to-year comparison of the Shelby County statistics with and without the requisite data. When we receive their administrative fee data, we will certainly update/amend this report as soon as their data is received.

Attached also are the detailed statistical reports outlining the administrative fees collected for 2017. Please let me know if you have questions or would like to discuss further. We are also happy to produce any additional comparative graphs or charts in whatever manner may be most helpful for your review.






## Number of Cases Defendants who were Appointed Counsel/ Public Defender or Private Attorney




## Percentage of Cases Where Admin Fee was Waived



## Number of Defendants Appointed a Guardian




## Percentage of Defendants whose Guardian Fee was Waived

I am writing on behalf of Richard DeSaussure, Criminal Court Clerk of the Thirtieth Judicial District of Tennessee to report that we are not yet able to submit the Administrative Fee Data.

As you know, we have had a plethora of problems with our new case management system. These problems are currently manifesting as an inability to get reports to correctly reflect what has happened. We have identified two major problems with the Administrative Fee report and we are working diligently to resolve them:

1. There was a problem with erroneous data being added to cases that were showing up on the report – we are currently auditing the results of the fix to see if it corrected all of the issues,
2. The report was incorrectly designed. It was pulling different information than what is required for this report. We think this is fixed, but we will not know for certain until problem 1 is corrected.

We are committed to getting this information to you, as soon as possible. Thank you for your patience


