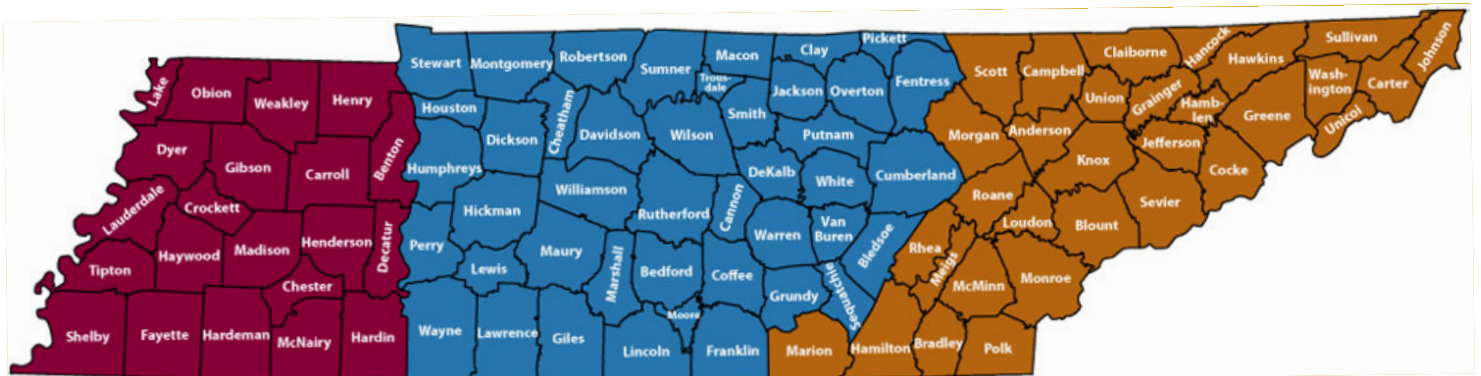

RE: Administrative Fee for Appointed Counsel

In 1997 the Tennessee General Assembly enacted Public Chapter 547 (T.C.A. 37-1-126 and 40-14-103) providing for the assessment of an administrative fee on all indigent criminal and juvenile delinquent defendants who are provided court appointed counsel. Court appointed counsel includes public defenders and private attorneys. The public chapter authorized an administrative fee between \$50 and \$200 per defendant. A separate law, Public Chapter 857 also requires the collection of additional data in cases in which a guardian ad litem is appointed in a juvenile dependency or neglect case.

The law specifically requires court clerks to submit monthly reports to the Administrative Office of the Courts. These reports contain the following information: the number of defendants appointed counsel and/or guardian ad litem, the number of cases in which a fee was assessed, the number of cases in which the fee was waived, and the dollar amount collected by the clerk's office and submitted to the Department of Revenue. The attached status report contains information received from the court clerks for calendar year 2018.

We are pleased to report that the Shelby County Criminal Court Clerk submitted their administrative fee data for calendar year 2018 in early March. They also submitted data for the remainder of 2016 and all of 2017. Our administrative fee data collection system closes the calendar year after the report is finalized. We cannot easily go back and update that data. We did not want to delay the transmission of the 2018

report. However, we will be happy to discuss how challenging the process of incorporating the remainder of the 2016 and 2017 data would be.

Attached also are the detailed statistical reports by county outlining the administrative fees collected for 2018.

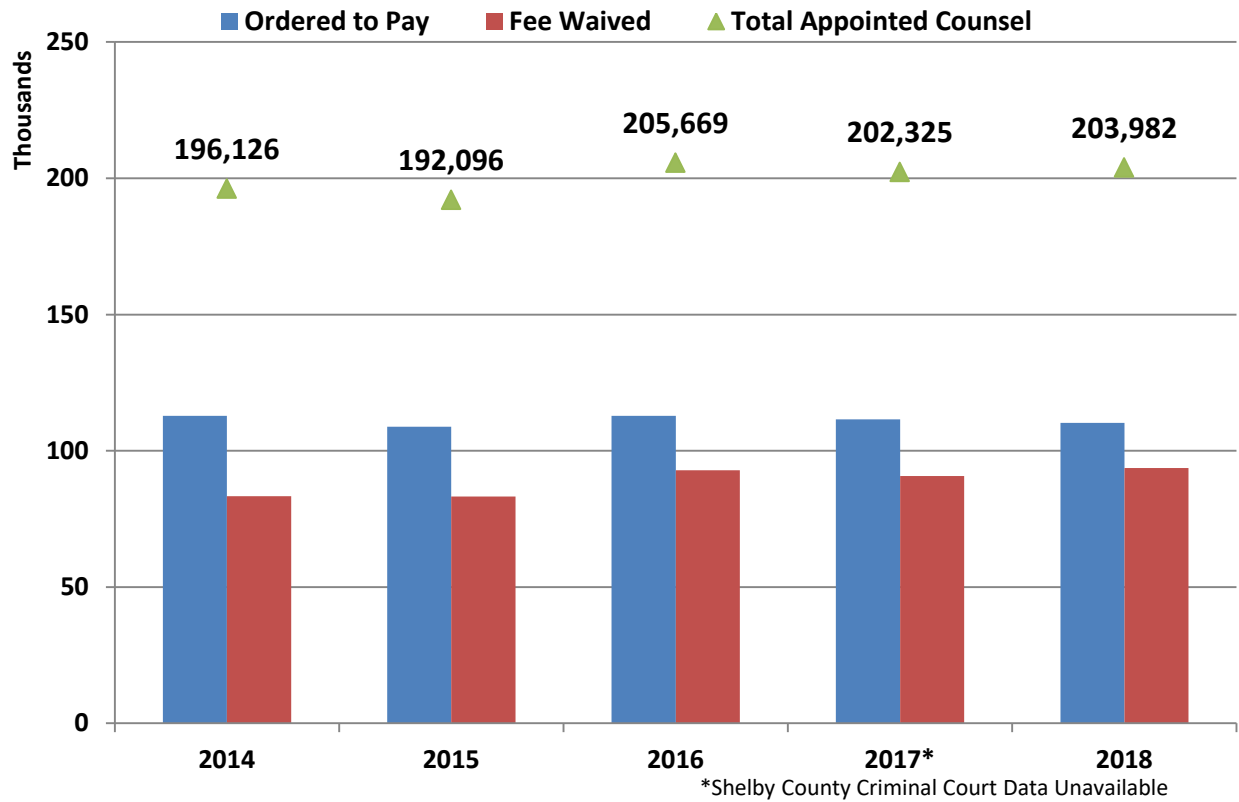

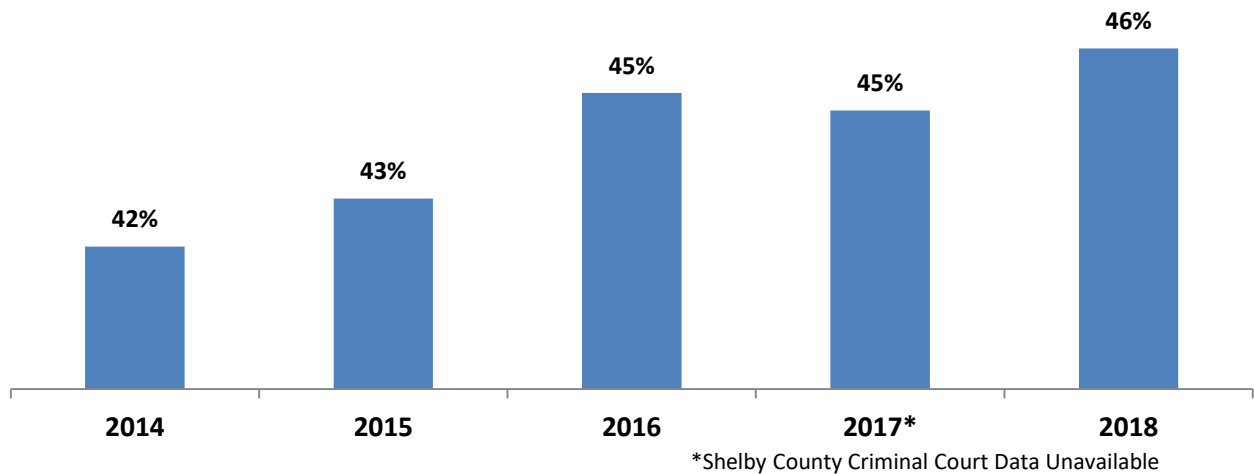

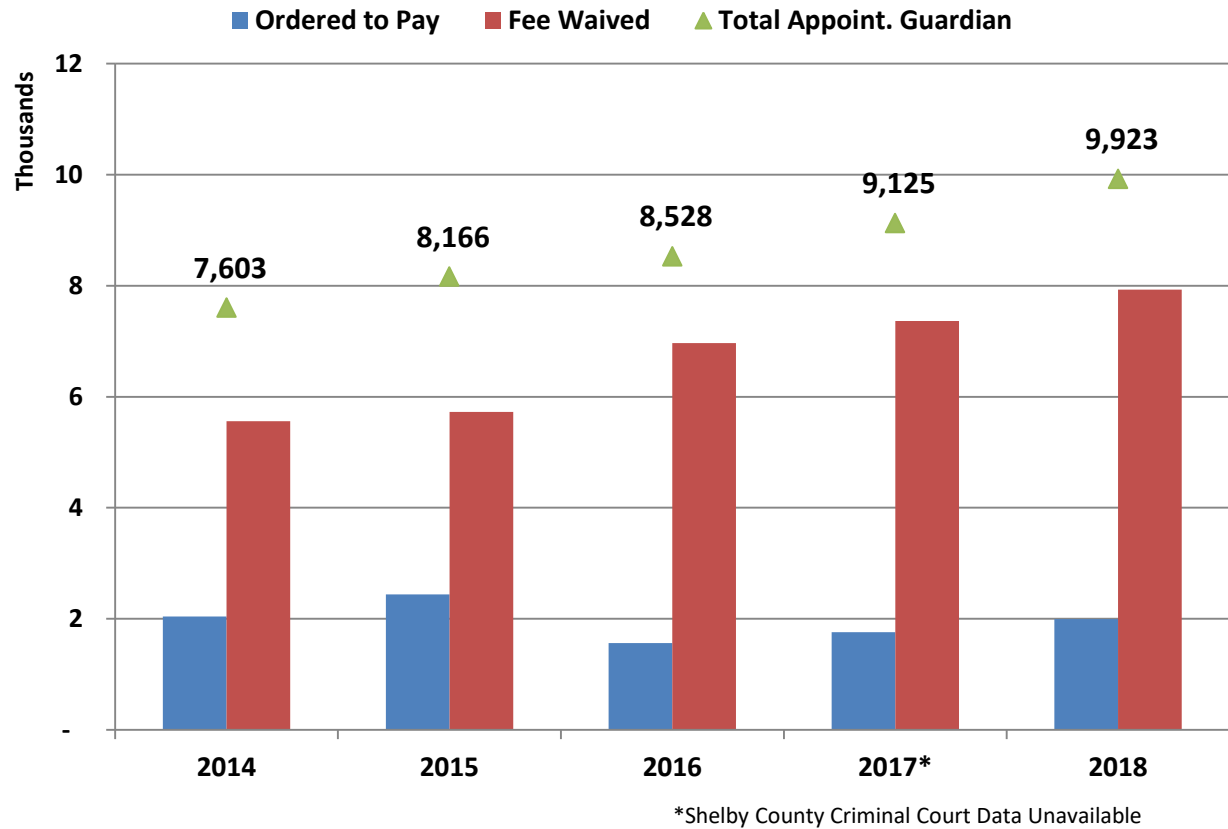
Number of Cases Defendants who were Appointed Counsel/ Public Defender or Private Attorney



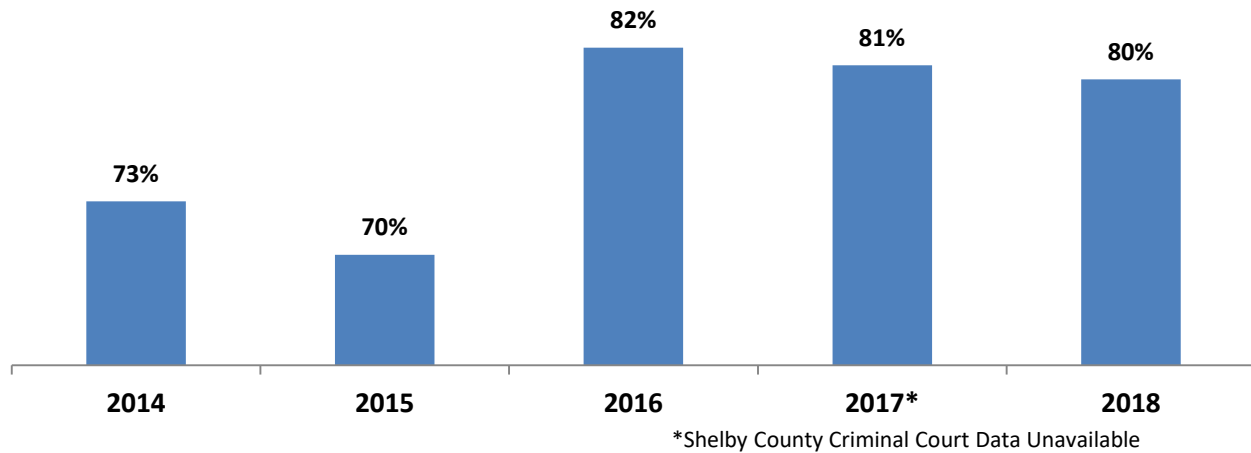
Percentage of Cases Where Admin Fee was Waived



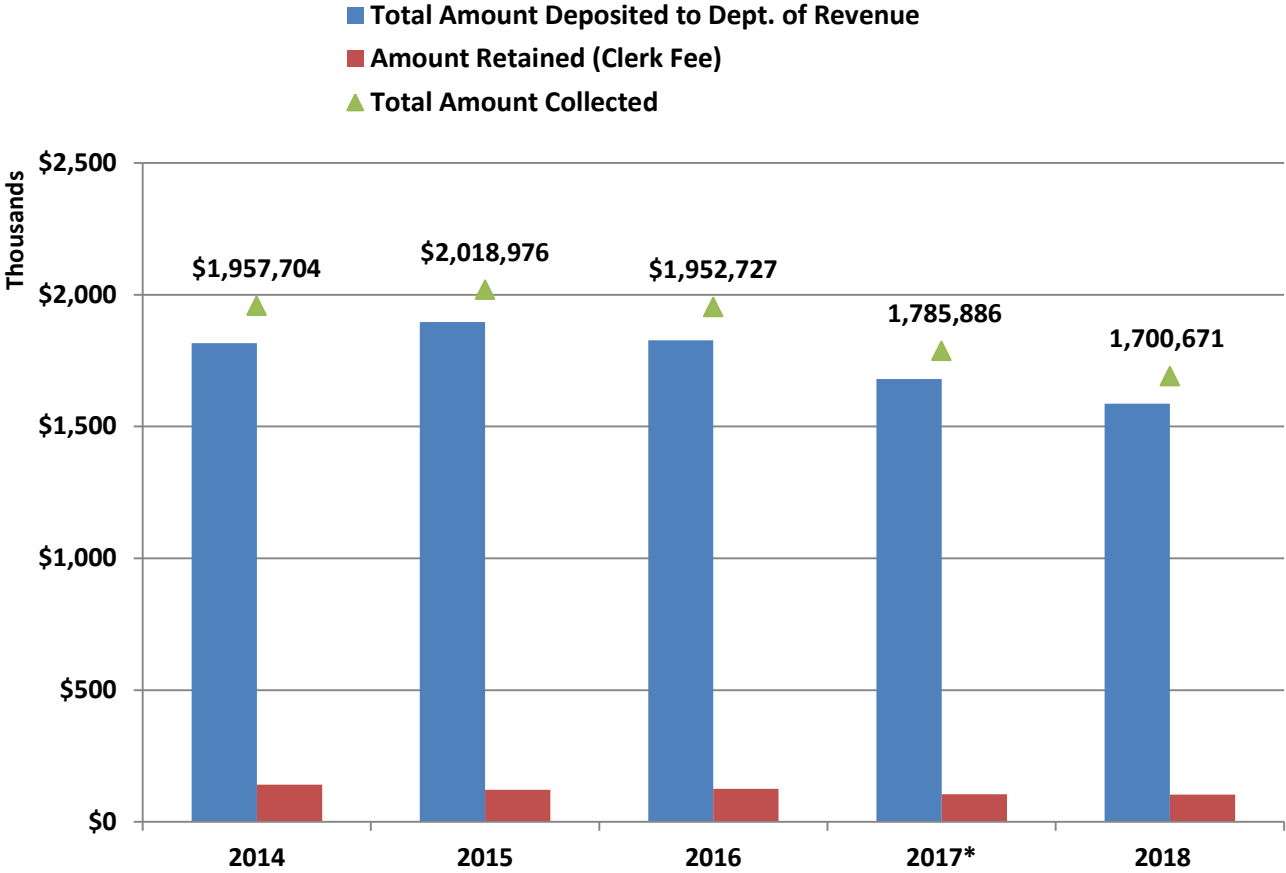
Number of Defendants Appointed a Guardian
