ORDER

Effective July 1, 2008, trial courts must impose a fine of \$25.00 for each drag racing violation, and these funds shall be earmarked for and paid into the Traumatic Brain Injury Fund. 2008 Tenn. Pub. Acts ch. 1048. Effective June 20, 2008, trial courts also must impose a drug testing fee of \$100.00 upon conviction for a violation of the Tennessee Drug Control Act, and these funds shall be deposited into the TBI Drug Chemistry Unit Drug Testing Fund. 2008 Tenn. Pub. Acts ch. 1201. Effective November 1, 2008, the Court hereby amends the judgment form attached to Tennessee Supreme Court Rule 17 to reflect these changes. The amended judgment form is attached to this order.
