#### **ORDER**

The motion for review filed by Ana R. Padilla, pursuant to Tennessee Code Annotated section 50-6-225(e)(5)(A)(ii), has been considered by the Court and is granted.

The parties shall submit supplemental briefs in accordance with Tenn. R. App. P. 29. The Court is particularly interested in briefing on the following issue: When an employee suffers an injury in the workplace as a result of a "neutral force" assault, is there a presumption that the injury is compensable, or does the employee bear the burden of proving that the assault was related to the employment?

The appellant's brief shall be filed within thirty (30) days of the date of this Order. The Clerk of the Court is directed to schedule this case for oral argument when the briefing is completed.
