

## AMENDED NOTICE OF JUDICIAL VACANCY

### **Court of Appeals Middle Section**

**The Governor's Council for Judicial Appointments hereby amends its notice published on January 24, 2022, in order to modify the application deadline and hearing dates for the imminent vacancy in the Middle Section of the Court of Appeals.**

Pursuant to the State of Tennessee Executive Orders No. 87 (September 17, 2021) and No. 95 (January 24, 2022), the Governor's Council for Judicial Appointments will meet on March 17 and March 18, 2022 to initiate the process of filling an imminent vacancy in the Middle Section of the Court of Appeals after Judge Richard H. Dinkins elected not to file a declaration of candidacy for retention.

Qualified applicants must be licensed attorneys who are at least 30 years of age, residents of the state for five years, and are residents of the Middle Section. Interested applicants must complete the Governor's Council for Judicial Appointments' application available at [www.tncourts.gov](http://www.tncourts.gov) and submit it to the Administrative Office of the Courts **by 12:00 p.m. CST on Monday, February 28, 2022.** Applicants must submit by the deadline: (1) the original signed (unbound) application; and (2) a digital copy of the application, in order to have his/her name placed on the list of candidates for consideration for this judicial vacancy for which he/she is applying. In accordance with State of Tennessee Executive Order No. 95 (January 24, 2022), the Council will hold this hearing virtually via video conference using Zoom on March 17 and March 18, 2022. Interested individuals may also attend the livestream in the Middle Section at the Administrative Office of the Courts located at 511 Union Street, Nashville City Center, Suite 600, Nashville, 37219 to watch and/or speak in opposition to any applicant. Visitors who want to attend the live stream hearing at the Administrative Office of the Courts must check-in with Nashville City Center building security for admission to the office.
